**MINUTES OF THE OCTOBER 26, 2022
CONSTRUCTION CONTRACTORS BOARD MEETING

The Construction Contractors Board (CCB) met on Wednesday, October 26, 2022, via teleconference.

MEETING CALLED TO ORDER:

Vice Chair Olsen called the meeting to order at 8:31 am.

DATE OF NEXT REGULARLY SCHEDULED MEETING: The next meeting is scheduled for December 7, 2022 in person or via teleconference from the 1st floor Hearing Room at 201 High Street SE, Salem, Oregon.

PUBLIC COMMENT:

No public comment

AGENCY REPORTS:

Chris Huntington, Agency Administrator discussed the budget with emphasis on response to the economic downturn. Staff recently began surveying contractors to learn reasons behind decisions to leave the industry. While the information collected will be helpful, Eric Olsen expressed concern that the data could be skewed due to the voluntary nature of the survey and suggested that staff randomly select a number of contractors to conduct a proactive poll. The leadership team will continue to make refinements to the Data Dashboard and address issues found through analysis of data. There was also discussion about methods to manage expectations related to processing timelines, such as website notification, contacting pre-license providers to share information with candidates, and continuing the practice of sharing timelines with customers who make contact with licensing staff.

Dana Zeimantz, Licensing Manager reported two big changes that are expected to reduce processing times and increase customer satisfaction. Process changes underway to reduce the number of administrative suspensions. There is also a project underway to accept new license applications and Lead Based Paint applications and renewals through an electronic payment and submission portal, which will reduce submission time for the customer, provide instant receipt for submission and payment, and shorten processing times. The State of Oregon employee retirement rate rose significantly during the 2020-2021 period and is still elevated in 2022, which speaks to a changing and competitive workforce, impacts of covid, and economic factors.

Noel Magee, Information Technology Manager reported that the firewall replacement was successful. CCB was granted an extension to January 15, 2023 to complete the requirements for multi-factor authentication as required by DAS and the IT staff understand what is expected. Work continues in preparation for the Licensing System Replacement regardless of the current budget situation.

Leslie Culpepper, Communication/Education Manager stated that the team is focused on project work, creating tutorial videos, designing a new webinar presentation for the 3-hour classes, which will include more LBP content and disputes in response to survey comments. Outreach events are filling the schedule and a new edition of The Tool Box will be coming out soon. Eric Olson asked staff to consider resources that may be available to help licensees navigate the economic changes on the horizon.

Vena Swanson, Enforcement Manager reported that she conducted field observations, allowing her to witness communications between contractors and consumers, coaching, and de-escalation techniques. The field staff will participate in onsite training in November that will include presentations by other agencies and the time will also be used to provide a much needed technology upgrade. Survey questions are being reviewed in an attempt to have responses reflect the DRS and mediation process without including factors outside of the CCB control.

Subject: 2022 CCB Summary of Achievements

Overview

As we draw to the close of 2022 (a statement I cannot really believe is real) I wanted to acknowledge the work that we have done as an agency. Unlike the tumult of 2020 and the recovery of 2021, 2022 has been marked by steady, deliberate and incremental improvements across the operation. You won't find any monumental changes noted below but the agency has dedicated itself to ongoing improvement efforts consistent with our adopted strategic focus areas:

- **Sustainable Financial Management:** Efforts will maximize existing resources to facilitate Long-term investments in staffing and Information Technology (replacing license system).
- **Accountable Service Delivery:** Efforts will demonstrate service and value to CCB customers – consumers and contractors.
- **Continuous Improvement:** Efforts will build the organizational culture and structures needed to support ongoing optimization of agency operations.

The areas noted below reflect a great deal of work on the part of management and staff as well as tangible benefits and improvements for the consumers and contractors of Oregon. Additionally, many of the enhancements below are self-reinforcing of additional improvements. This can occur through improved efficiency, lower costs or improved staff capacity that can be directed to better serve our customers.

Meeting Financial Goals

The agency focus over the past several years has been to correct the effect of the “triple bind” that was identified in 2020 -- *depleted reserves, economic uncertainty and seriously needed long-term investment*. The remedy was to curb spending, project conservatively and build reserves. The end goal was to put the agency in a position to both weather a financial downturn, which may finally have arrived, while also being in a position to make needed investments. The agency currently retains in excess of its target threshold (six months of reserves, plus \$750K toward license system). This positions the agency to navigate any additional financial downturn while also pursuing needed long-term investments.

Making Targeted Investments

Having reached the threshold identified above the agency has moved to cautiously fill some positions that had been held vacant. The focus of these new positions are in areas that support the strategic aims of service delivery and continuous improvement. The agency has added an analyst to support continuous improvement efforts, filled the policy analyst position and restored budget services to the agency from DAS.

Information Technology Infrastructure and Security Enhancements

CCB has made multiple improvements this past year in the security and modernization of our IT infrastructure. Most notably this included the long-awaited replacement of the agency's firewall, which improves the agency's security posture significantly. The agency also completed (or is near completing) several DAS initiated projects including multi-factor authentication for agency staff as well as an Enterprise security assessment. The IT staff also found time to investigate and eliminate several potential security issues, which has resulted in vulnerability scans that have remained consistently above the statewide average.

Front Counter Service Delivery Revamped

As the agency prepared to accept in-person service at the beginning of 2022, the agency took the opportunity to change our service delivery model. Rather than two permanently dedicated front-counter staff, the agency has rotated staff through that assignment. This has provided an ongoing opportunity for cross-training licensing staff to be multi-functional.

Automating Processes

The IT group has also assisted in helping the agency to automate certain processes, eliminating manual steps and improving our efficiency and reducing our costs. Examples include automating our reporting to Department of Revenue for penalty payments and moving to electronic reminders for license and insurance renewals. Each of these eliminate manual steps, improve efficiency and reduce cost to the agency.

Established and Hired Continuous Improvement Analyst

The agency used a vacant IT position to create a new position within the agency whose sole focus is on leading continuous improvement efforts and supporting staff training and development around areas of improvement. This position assists in implementing many of these changes (data dashboard, non-renewal survey, deploying new equipment etc.) and also supports staff through these changes by developing staff training resources and "how to" guides.

Agency-wide Cross Training

A key focus area across the agency has been in cross-training staff to be multi-functional, to understand multiple roles and to be able to step in and provide support as needed. This effort is integral to helping the agency improve the efficiency of our operations and provide support as we navigate any potential economic downturn without impacting service delivery. Key examples include:

- Continue expansion of field mediator cross-training;
- Expand training for field mediators to conduct phone mediations
- Beginning cross-training compliance specialists for background screening and case handling
- Documentation of background screening process and development of training modules
- Cross-training licensing staff on front counter and in-office staff responsibilities

Updates to All License Applications

All license applications were revised and updated to provide clearer direction and to eliminate common "traps" that lead to errors that can be time-consuming. The applications are now also all PDF-fillable, which will also support the move to electronic submission.

Improved Utilization of Data

The agency has made an effort to improve the utilization of data and to improve our methods of collecting and reporting data and how that information is used in operational decisions. Examples include the newly revised data dashboard and the implementation of the non-renewal survey.

System Replacement Documentation and Planning

In mid-2022 the agency re-initiated the license system replacement project by revising and updating our business plan and charter. The agency's business plan was noted for its excellence and staff at DAS requested the chance to use our business case as an example for other agencies. CCB continues to make steady progress on the voluminous planning and documentation needed and still plans to initiate an RFP at some point during the 2023-2025 biennium.

Established Formal Onboarding Program for New Staff

The agency had never had a formal onboarding, training and orientation program prior to 2022. Usually staff onboarding and training was ad hoc. This new program provides detailed checklist for managers and other leaders as well as scheduled training and orientation program to orient new staff to the agency and their new role.

Spanish-Language Resources

The agency improved our resources and information available to Spanish language contractors and consumers. This included the creation of a Spanish language "hub" on the website that consolidated all of the Spanish language information and resources currently available. We also initiated a Spanish language version of the toolbox newsletter.

Improvements to Spanish language test pass rate

CCB also began a review of the examination process through PSI particularly for those testing in Spanish, where the pass rate has been historically low (around 20%). While the project is ongoing, the agency has made some simple changes to the resources and information available to Spanish language PSI examinees and has seen the pass rate increase over the last 5 months to 50%, which is about a 30% increase over prior performance.

Education Updates and Communication Enhancements

The agency updated the CCB's 3-hour required webinar to make it more interactive and make better use of the dynamic tools available in the webinar context. The agency also made changes to our outreach and communication with contractors about their education requirements to ensure that contractors complete their education and remain in compliance.

Inter-agency Cooperation on Enforcement

CCB renewed the BCD inter-agency enforcement contract at a more advantageous rate that will help provide steady and ongoing financial support for enforcement efforts. In addition the agency held a multi-agency in-person training session with all field staff as well as representatives from BCD and OHA.

Dispute Resolution Process Overhaul

The dispute resolution team has been engaged in an ongoing effort to overhaul and streamline the process for greater efficiency, reduce some of the time lags and provide a better overall experience for participants. This includes increased use of electronic communication as well as changes to the survey process for more immediate feedback.
