Oregon Board of Examiners for Speech-Language Pathology & Audiology 5/6/22

Proposal to update the language of Chapter 335, Division 5: Professional and Ethical Standards. Specific goals, to broaden the scope of protections for recipients of services, students, and colleagues against discrimination to align with protections in place in the ASHA Code of Ethics and State of Oregon (e.g., BOLI).

Proposed:

- (4) Individuals shall not discriminate in the delivery of professional services on the basis of language, dialect, race, color, ethnicity, religion, national origin, ancestry, age, disability, sex, gender, gender identity and/or expression, sexual orientation, military, veteran status, or any other protected classification recognized by applicable law.
- (7) Individuals shall not discriminate in their relationships with colleagues, students, and members of allied professions on the basis of language, dialect, race, color, ethnicity, religion, national origin, ancestry, age, disability, sex, gender, gender identity and/or expression, sexual orientation, military, veteran status, or any other protected classification recognized by applicable law.

Welfare of Clients 335-005-0015

(4) Individuals shall not discriminate in the delivery of professional services on the basis of race or ethnicity, sex, age, religion, national origin, sexual orientation, or disability.

Professional Competence 335-005-0020

(7) Individuals shall not discriminate in their relationships with colleagues, students, and members of allied professions on the basis of race or ethnicity, gender, age, religion, national origin, sexual orientation, or disability.
