

## **Changes in the January 2024 Handbook are as follows.**

### **Cover Page**

This page was updated to show the revision date of 01/24.

### **Chapter A, General Title Requirements**

The Dealer Checklist has been reformatted and now includes information concerning DEQ and VIN inspections.

### **Chapter D, Miscellaneous Title Application Information**

Due to legislation the VIN inspection fee is now \$9.

Any Oregon law enforcement agency can now perform VIN inspections.

### **Chapter G, Operation of Law**

The Inheritance Affidavit, Form 516 has been replaced with the latest revision dated 5-23. The Vehicle Repossession Certificate, Form 263 has been replaced with the latest revision dated 6-22.

### **Chapter H, Odometer Disclosure Requirements**

The older version of the Secure Power of Attorney, Form 402, with carbon copies is still acceptable.

### **Chapter K, Registration**

Due to 2023 legislation, new motorcycles and mopeds are no longer eligible for four-year registration, only two-year registration.

The replacement plate fee, whether between or at renewal, is now \$12.

Vehicles with a model year of 2021 or newer are exempt from DEQ requirements.

### **Chapter L, Vehicle Types**

The definition for certain ATVs has changed. Hybrid and electric mopeds and motorcycles are no longer eligible for four-year registration.

### **Chapter M, Fees**

The following changes are due to 2023 legislation:

- The plate transfer fee is \$30.
- The replacement plate fee is \$12 at any time.
- The VIN inspection fee is \$9.
- A single plate is \$13.
- Two plates are \$26.
- New mopeds and motorcycles are not eligible for four-year registration.
- A Tow Board fee of \$100 has been added to the \$17 fee for a tow business certificate. The Tow/Recovery Vehicles Fee Schedule, Form 148, has been replaced with the latest revision date of 1/24.
- The Motor Home Schedule of Registration Fees, Form 465 has been replaced with the latest revision date of 1/24. Note the fee changes.
- The Camper and Travel Trailer Schedule of Registration Fees, Form 464 has been replaced with the latest revision date of 1/24. Note the fee changes.

### **Chapter O, Tow/Recovery Vehicles**

A Tow Board fee of \$100 has been added to the \$17 fee for a tow business certificate. The Tow/Recovery Vehicles Fee Schedule, Form 148, has been replaced with the latest revision date of 1/24.

### **Chapter R, Dealers**

Document fees, dealer plate transfer fees, the integrator fee, trip permit book fees have changed due to 2023 legislation.

Normal business hours have been defined.
