*****(4)(d) That the applicant has been convicted of violating a general or local law of this state or another state, or of violating a federal law, if the conviction is substantially related to the fitness and ability of the applicant to lawfully carry out activities under the license.

Commission staff proposed to issue the requested Full On-Premises license with the following restrictions:

Licensee Pattaraporn Lorwatcharasophon shall not be convicted of driving while suspended, driving uninsured, operating a vehicle without driving privileges, driving in violation of restrictions, or a similar conviction, in the State of Oregon or any other state.

Note: Applicant was issued a Notice of Proposed License Restriction (Notice), dated July 7, 2021. Applicant accepts the imposition of the listed restriction and wishes to dispose of this licensing matter by settlement.

SYNOPSIS: Applicant has five violations for driving while her license was suspended and one violation for failing to carry proof of insurance, which constitute violations of general or local laws that are substantially related to the fitness and ability of the applicant to lawfully carry out activities under the license and are therefore a basis to deny the license.
