## MANUFACTURER & WHOLESALER SUPPLIER SUPPORT CONTENT

This document summarizes some of the primary OLCC resources available to suppliers of alcoholic beverages in Oregon – many of whom are new to Oregon and/or the alcoholic beverage industry.

## WHAT IS A "SUPPLIER" IN OREGON?

- Manufacturers and wholesalers of alcoholic beverages in Oregon and their respective agents
- Any manufacturer or wholesaler of alcoholic beverages whose products are sold in Oregon
- Any person who imports or causes to be imported an alcoholic beverage into Oregon for sale or distribution within Oregon and their respective agents
- Brewery-Public House license
  - Note that as per Oregon Revised Statute (ORS) 471.200, a Brewery-Public House license is both a supplier and a retailer

## WHAT ARE EXAMPLES OF SUPPLIER INQUIRIES?

- Manufacturing, wholesaling, and distributing alcoholic beverages in Oregon
- Importing alcoholic beverages into Oregon
- · Tied house and prohibited financial connections, and relevant exceptions
- Prohibited, or possibly prohibited, financial assistance
- Advertising, including coupons
- Malt beverage territorial agreements
- Privilege taxes and privilege tax bonds
