___ **Thomas R. Dargan Award of Excellence**

Eligibility:

- 1) An adult individual who has made a significant statewide impact to the alcohol and drug abuse prevention, treatment, or recovery profession for a minimum of 10 years.
- 2) The nominee demonstrates effective leadership, with genuine concern for improving the humanity of all.
- 3) Unselfish efforts have inspired others to maintain their commitment to make the community a wholesome and thriving place.

___ **Outstanding Youth Community Service Achievement Award**

Eligibility:

- 1) An individual under the age of 21, a youth organization, or a youth business.
- 2) Has made a significant impact on alcohol and drug abuse prevention, treatment or recovery in their local community.
- 3) Community support is active, visible, and effective.

___ **Outstanding Community Service Achievement Award, *Organization***

Eligibility:

- 1) School program, parent group, religious organization, civic organization, law enforcement, business, service provider, community coalition, organization, or business.

- 2) Has made a significant impact to alcohol and drug abuse prevention, treatment or recovery in their local community.
- 3) Community support is active, visible, and effective.

____ **Outstanding Community Service Achievement Award, *Individual***

Eligibility:

- 1) An individual associated with a school program, parent group, religious organization, civic organization, law enforcement, business, service provider, community coalition, organization, or business.
- 2) Has made a significant impact to alcohol and drug abuse prevention, treatment or recovery in their local community.
- 3) Community support is active, visible, and effective.

____ **Clark Campbell Outstanding Media Achievement Award**

Eligibility:

- 1) The media product may include public service campaigns, documentaries, editorials, and other special initiatives and campaigns.
- 2) The media product is developed to educate, inform, and otherwise reduce alcohol and drug abuse problems on a national, state wide or local level.

____ **Outstanding Innovations in Government Achievement Award**

Eligibility:

- 1) Individual, team, or agency at local, County, State or Tribal levels.
- 2) Substantially changed and improved government practice or policy to better meet the need of Oregon residents in alcohol and drug abuse services and programs.
- 3) Changes and improvements have potential to be replicated beyond original agency or community.
