Legislative updates	The legislature is still in session, but they are down to working on the budget. The HPV bill has passed the house and senate. The clinical trial bill has passed the house and senate. The breast cancer treatment bills are in the ways and means committees (which is where they determine how they are going to pay for it). The clinical trail bill will give people have their normal standard of care. There are several tobacco bills. The landlord disclosure is a bill that mandates that a landlord has to disclose if they allow smoking or not and the governor has signed that bill. The Cigarette vending machine bills was amended to allow machines in bars and taverns and is under OLCC rules no one under 21. The banning of free samples bill passed out of the house and hearing in Senate and is referred to the Senate Rules committee. It got sent the rules committee due to the moist snuff bill, the bill that passes last is the bill that is real. Smoking in cars with children is out of the senate. The Governors Tobacco Tax and is not moving ahead. Obesity prevention – Good partnerships. Menu Labeling passed – chain restaurants need to post calories on menu boards. Komen is backing the breast cancer and treatment bills and they were asked about which they were more interested in, due to the possibility of getting more money for one or the other and not both.

How do we make sure to get input and start at a place that is not at the beginning and be available to address other issues Karen would love to hear any suggestions on how to do this and best use everyone’s times so that is not reinventing the wheel.
