Morning will have presentations regarding breast health, survivor story at lunch. There is a flyer (Sara will forward to all).The goal is 75 attendees, it will be at the community center. The goal is to track that more women with disabilities are able to get mammograms. There will be an ad in the paper</li> <li>Portland- October 20-22 (To Be Determined).
