

Contract counties are responsible for all community water systems with groundwater sources serving less than 3,300 people as well as all nontransient, noncommunity and transient noncommunity water systems. Operators and managers of these systems should call their county health department first for assistance with drinking water issues. State staff is responsible for all community water systems using surface water sources and those community systems serving 3,300 or more people.
