Energy Tax Credit program offers tax credits totaling up to \$1,500 if you buy a qualifying new alternative fuel vehicle with an on-board charging system. You claim the tax credits when you file your state income tax.

The Oregon Residential Energy Tax Credit program was established to encourage residents to invest in energy-saving appliances, heating systems and alternative fuels. Hybrid vehicles have an electric motor and transmission system that allows the vehicle to use electricity as an alternative fuel. These vehicles are eligible for a credit even if they use conventional fuel as back-up or staple fuel. They also have regenerative brakes designed to recover energy from stopping to re-charge the battery.

The tax credit for new alternative-fuel vehicles is \$750 or 25 percent of the cost, whichever is less. A second tax credit is allowed for the on-board hybrid charging system and is also \$750 or 25 percent of the cost*, whichever is less.

To qualify for a tax credit, you must have an Oregon income tax liability. You claim the tax credit when you file your state income tax. If you are an Oregon resident and do not have an Oregon income tax liability, you may choose to transfer your tax credit to an Oregon resident who does. The Pass-through Option will allow you transfer your tax credit to an individual or business with an Oregon tax liability who will make a lump-sum payment to you equal to 95 percent of the certified tax credit amount. To use this option, complete this application form first. Your application will be reviewed for eligibility. A Pass-through Option Application will be sent to you in return. You and your pass-through partner (the tax credit recipient) will complete and sign the Pass-through Option Application and mail it to the Oregon Department of Energy. You are responsible for finding your own pass-through partner. The Department of Energy will then issue the tax credit certification to the pass-through partner. There may be tax implications for the pass-through partner. We advise you to consult with your tax preparer.

Don't wait to apply for the tax credit. You'll receive a Certification that you will need when you file your tax return.

Eligibility criteria for alternative fuel vehicle with on-board charging system:

- The vehicle must be new and registered and licensed for roadway use by the Oregon Department of Motor Vehicles.
- Only the contract owner or purchaser of the vehicle is eligible for the tax credits.
- An operator of a qualifying vehicle with a lease (or a lease with an option to purchase) may claim the tax credit. You must attach a letter of authorization with your application form allowing you to claim the credit on behalf of the owner (lessor). The letter must be signed by the owner.
- The on-board hybrid charging system must meet all state and local fire and life safety codes.

* The cost of the on-board hybrid charging system (regenerative braking, charge controller, battery/engine link-controller) is generally not an itemized cost item. Hybrid vehicle manufacturers have verified that the cost is more than \$3,000 in all cases. The Oregon Department of Energy will use the \$3,000 figure that allows you the full tax credit of \$750.

If you meet these criteria, follow these steps to receive your tax credit:

- 1. Complete the Application and Verification Form for Residential Energy Tax Credit Certification – Hybrid Vehicle.** The form may be filled out on your computer. Please print it, sign it and mail it with your receipt to the Oregon Department of Energy. The forms can NOT be filed on-line. Provide proof of payment. This would include a copy of your dated purchase receipt, contract or invoice documenting the vehicle is paid in full. It could also be proof of lienholder interest from your bank or credit union if you financed the car. These documents should clearly identify the car including Vehicle Identification Number (VIN), your name, the dealer's name, the lienholder's name (if applicable), and the purchase price amount.
- 2. Submit the application to the Oregon Department of Energy.** If your paperwork demonstrates that your equipment and/or system qualify for the tax credit, the Oregon Department of Energy will approve your application and send you a signed System Certification with the qualifying tax credit amount.
- 3. Claim your tax credit on your state income tax form.** Keep your Certification, a copy of your application and proof of payment for your records. Do not attach them to your tax return. Upon audit or examination, the Oregon Department of Revenue may ask you to provide the information to verify your credit claimed. Tax credits, or portions of the tax credit, not taken in the first year may be carried forward up to five years.
