User Agreement (Signature Required)*

BY CONNECTING TO THE CLASS SYSTEM OR INSTALLING THE CLIENT SOFTWARE, YOU ARE CONSENTING TO BE BOUND BY AND ARE BECOMING A PARTY TO THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, MAKE SURE TO UNINSTALL THE CLIENT SOFTWARE.

You agree, in consideration for the privilege of using CLASS CONFERENCING, to the following terms and conditions.

All use of CLASS shall be subject to the following conditions and restrictions on Video and Online Services' liability. These conditions of Use of CLASS CONFERENCING are independent of, in addition to, and not in limitation of any agreement or contract established between Video and Online Services and any user of CLASS.

The use of, and access to, CLASS is a privilege, which may be revoked at any time, in the exclusive and unlimited discretion of (by) the administrators of the system (at any time) for abusive conduct. Such conduct (would) includes, but is not (be) limited to, the placing of unlawful information on the system, and the use of obscene, abusive or otherwise objectionable terms, displays or language in either public messages or (upon registration of complaints about) private messages. CLASS is established pursuant to, and exclusively for the purposes stated in, ORS 354.505 to 354.550, and does not constitute a public forum for uncontrolled expression. The staff of CLASS will be the sole arbiter of what constitutes obscene, abusive or objectionable language.

1. Video and Online Services Control of Content

No user has the right to rely on the confidentiality, or the preservation of the confidentiality, of any material that the user places on CLASS. CLASS reserved the right to review any material stored in files to which all users have access, and will edit or remove any material, with no liability on the part of CLASS for such editing or removal, which the staff, in its sole discretion, believes may be unlawful, obscene, abusive or otherwise objectionable.

2. Responsibility for Abuse of Intellectual Property Rights

No person shall use CLASS, without previously obtaining the express written consent from the holder of such rights, to enter, send, broadcast or other wise communicate information, data or material in which another person or entity has patent, copyright or other proprietary interest. The user shall be exclusively responsible for the content of any message the user places on CLASS, and shall indemnify, defend, and hold the State of Oregon, Video and Online Services, their officers and employees harmless from any claim, demand, expense, cost or attorney's fees resulting from arising out of the content of any message, including but not limited to claims of patent or copyright infringement, appropriation of proprietary rights, invasion of privacy, or defamation.

3. No Video and Online Services Warranties

CLASS makes no warranty or representations, and expressly DISCLAIMS ALL WARRANTIES concerning the operation, maintenance or performance of CLASS, including but not limited to warranties of merchantability or of fitness for a particular purpose of CLASS or any component thereof. No refunds.
