THE CONDITIONS OF THIS OBLIGATION ARE SUCH THAT:

WHEREAS, the Principal has made application to the Oregon Department of Transportation for a license to engage in business as a DEALER in motor vehicle fuel, SELLER of Use Fuel, AND/OR USER of Use Fuel as authorized and as required by ORS 319.010 through 319.880.

NOW, THEREFORE, if said Principal shall comply with all the conditions imposed by ORS 319.010 through 319.880 and subsections 1 through 5 of 319.990 then this obligation shall be null and void, otherwise to remain in full force and effect and it shall be a continuing instrument and shall cover any and all periods of time including the first and all subsequent periods for which a license may be granted in consequence of the giving of such bond. Any recovery on this obligation will not invalidate any future recovery, up to the limit of the sum stated above. The surety on this obligation may be released and discharged from any and all liability to the State accruing on this bond only after the expiration of 60 days from the date upon which such surety shall have filed with the Department a written request to be released and discharged, but this provision shall not operate to relieve, release or discharge the surety from any liability already accrued or which shall accrue before the expiration date of the 60 day period.
