PPD wants a way to temporarily suspend the license within the first 48-72 hours to enforce a cooling off period. OLCC asks for voluntary closure within a few days of any high-risk incident. Could there be a quicker hearing for immediate suspension? <b>How best to deal wth problem premises other than immediate suspension? When a pattern is seen deveopling, the licensee is asked to come in and talk with OLCC and the police to create a plan to get the premises back on track. At this time, the proposed plan is voluntary. Some members feel that an enforceable compliance plan would need to have some teeth. Rulemaking has begun regarding same. More details in the January meeting minutes.</b></p>
