# **Hot Topics:**

- **Billables** Erin provided the information regarding billables. Any direct shipped vaccine cannot be billed and that includes Varivax, Pfizer, COVID vaccine, ProQuad. LPHAs are expected to have privately supplied Varivax similarly the way they receive privately supplied flu vaccine.
- Vaccine Finance- Kelly shared the Barriers and the strategies to reduce those barriers for providers, around enrollment in programs and the cost. The formation of a vaccine finance support steering committee is underway. This committee aims to diminish barriers and enhance access.
