ORCA/CDM Supplement

A supplemental guidance document that modifies how the Department's Core-Development Manual (CDM), version 3.1, is administered with Projects and Project Teams that are participating in the OHCS Oregon Centralized Application (ORCA).

1.01__Overview

This ORCA/CDM Supplement, hereinafter referred to as, Supplement, modifies how the current CDM, version 3.1, is used with projects that are participating in the **Oregon Centralized Application (ORCA)** process.

1.02_Modified Applicability of the CDM to ORCA Applicants

This Supplement exempts ORCA Applicants from compliance with parts of the CDM Version 3.1 as given in the table below. All operationally pertinent sections of the CDM that are shown in the table below as "not applicable" are now integrated into the ORCA itself.

All Parts of the CDM not referenced in the above table are unchanged by the ORCA and remain applicable to ORCA applicants.

1.03_ORCA Tasks (CDM Specific)

ORCA applicants must follow the task-based protocol for CDM compliance given in the table below. CDM related tasks are listed sequentially, generally in the order that they will need to be completed over the duration of the ORCA process. The ORCA itself establishes the timing, required submission protocol, and any performance thresholds that may exist for each of the tasks listed below. This ORCA/CDM Supplement provides guidance on what is needed to complete each task prior to submitting it into the ORCA process for Department review.

Important Notes:

- 1) Required deliverables as given in column 4 of the table below must meet the task requirments established by the guidance given in column 3.
- 2) Required deliverables must be submitted using the timing and document submittal protocol guidance given in the ORCA itself. Refer to the ORCA for this information.
- 3) CDM Forms referenced in column 4 can be accessed on the CDM webpage under "Forms". They are also available within the ORCA itself.
