What is the GAC

- Provides guidance and advisory to agency staff and engagement in problem solving for the Outfitter and Guide and the Charter industry in Oregon.
- Provides recommendations on various matters related to the Outfitter and Guide and the Charter Industry in Oregon.
- Will comply with open meeting, public record, and ethics laws.

• Authority: the Marine Board shall appoint a Committee in accordance with ORS 704.525 and OAR 250-016-0090

What the GAC can expect from OSMB staff

- OSMB staff support the GAC through:
 - Meeting planning, preparation, and facilitation
 - Timely communication
 - Coordination of communication between the GAC members
 - Development and distribution of the meeting materials
 - Provide meeting agendas and materials in advance of each GAC meeting

Committee Meetings

- The objective of the Committee meeting is to ensure that Marine Board staff are informed, advised, and engaged with outfitter guides and the charter boat industry professionals.
- The Marine Board is a "public body" as defined in ORS610 192.610(4) and the Committee is considered a "governing body" as defined in ORS 192.610(3).
- A "governing body" has the authority to make recommendations to a "public body" or administration.
- The Committee does not have authority to make rules or statutory changes to the Marine Board administration.

Public Meeting Law

- GAC is subject to Oregon's Public Meetings Law
- Public notice of meetings and meeting materials
- Meetings livestreamed and recorded
- Public is viewer of meeting but does not participate
- Committee members should email agency staff only, please do not email each other

Operating Principles & Guidelines of GAC members

- Act in good faith
- Stay on topic
- Balanced speaking time
- Address issues and questions, not people or organizations
- Discuss topics together
- Communicate on behalf of the group you represent
- Attend all meetings
- Come to meeting prepared
