


Mental Health Claims

<u>SB 507</u> from the 2019 legislative session created a rebuttable presumption for certain public safety workers that post-traumatic stress disorder and acute stress disorder are compensable occupational disease for claims filed on or after Sept. 29, 2019.

- From 2016 to 2022, the number of mental health accepted disabling claims (ADCs) among first responders increased from 8 ADCs per year to 59 ADCs per year, an increase of 638 percent.
- On the other hand, the number of mental health ADCs among non-first responders increased from 66 ADCs to 112 during that same time span, an increase of 70 percent.
- In 2016, 11 percent of all mental health ADCs were by first responders. That percentage rose to 35 percent in 2022.

First responder category of occupations:

- 1) Law enforcement officers, including corrections officers 102 accepted disabling claims (ADCs) in the past 7 years,
- 2) Firefighters and fire investigators 16 ADCs in the past 7 years,
- 3) Managers of law enforcement officers, including corrections officers 20 ADCs in the past 7 years,
- 4) Emergency medical technicians 9 ADCs in the past 7 years,
- 5) Managers of firefighters 6 ADCs in the past 7 years, and
- 6) Dispatchers 4 ADCs in the past 7 years.

Please note that these numbers do not include City of Portland firefighters and police employees, as this entity is not required to report claims to the division per Oregon Revised Statute 656.027(6). Data reflected is only accepted disabling claims (ADCs).
