Universal Health Plan Governance Board (UHPGB) Meeting Thursday, November 21, 2024 Minutes

Call to order:

Chair Helen Bellanca called the meeting to order at 9 a.m.

Board members present:

Welcome and Introductions:

Written public comment submissions

Chair Bellanca briefly summarized and thanked the members of the public who submitted written public comments for the board to review.

Approval of October 17, 2024, Board Meeting Minutes:

Amy Fellows made the motion to approve the minutes and Debbie Diaz provided a second to the motion. There was no discussion. Chair Bellanca called for a board vote:

Executive Director's Report: 00:07:38

Executive Director Morgan Cowling shared the following staff updates:

- Jessica Merino and Danielle Ross are settling into their OHA policy analyst roles, supporting the board. OHA staff members, Laurel Swerdlow and Devlin Prince, remain in their staff support roles and are training Jessica and Danielle.
- Staff has been focused on getting committees up and running and setting them up for success.
- Committees are requesting "work groups", whereas right now, policies and procedures dictate that only the board can establish work groups. This should be discussed by the board in the future.
- Staff is continuing to build capacity for the board and committees.
 - Diana Bianco, Artemis Consulting, will be starting Dec. 1st to support the Community Engagement and Communications Committee (CECC)
 - Health Management Associates (HMA) have been hired on to provide health policy support to committees

- Working with Department of Consumer and Business Services (DCBS) procurement team on the "request for proposal" (RFP) to hire on additional contract support for the board's work. There will be a need for board member volunteers to create an "evaluation committee" for the RFP. More to come later on this.
- Applications to fill the public engagement seat on the board were due Nov. 15. Director Cowling, Chair Bellanca and Vice-chair Richardson are reviewing all applications and will submit their candidate recommendations to the Governor's office for final selection and approval. If any board member(s) would like to be a part of this process, please reach out to Chair Bellanca.
- Governor Kotek will be releasing her budget on December 2nd, which will include the continued proposed funding for the UHPGB.
- The board has received 12 public records request since it's establishment. The public remains very interested and engaged in this work and staff prioritizes responding promptly to all requests.

ERISA Memo to Joint Task Force on Universal Care

The board received a presentation from guest speakers and ERISA experts, Erin Fuse Brown and Liz McCuskey. Erin Fuse Brown and Liz McCuskey were consultants to the Joint Task Force on Universal Care, which proceeded the UHPGB, and provided the board with a summary presentation of their ERISA research for the Joint Task Force, which was included in the Joint Task Force's final report.

- After board discussion, the following suggestions were made:
 - Can staff track how many of the health care systems in Oregon are self-funded? (I.e. Kaiser, Providence).
 - Finance and Revenue Committee need to keep in contact with Erin Fuse Brown and Liz McCuskey regarding the committee's finance recommendations, to ensure there is not an ERISA challenge.

Executive Session for Department of Justice (DOJ) Legal Advice:

Chair Bellanca announced that the UHPGB will now be entering into Executive Session pursuant to ORS 192.660(2)(f). Only board members, staff, media, and board's council are able to attend. No decisions or votes will be made during Executive Session.

Chair Bellanca reviewed the current board policy regarding communication. Through board discussion, the board weighed whether to amend the current policy.

Debbie Diaz made the motion to amend the Universal Health Plan Governance Board's communication policy to "The board and its committees hold a firm commitment to transparency and the preservation of public trust. The board also recognizes the importance to have some limited communication among members to facilitate the board's work and accomplish its deliverables as laid out in Senate Bill 1089. Communication among less than a quorum of the board is permitted, as long as it does not create a serial communication creating a quorum. A quorum of the members of the board will not, outside of meetings conducted in compliance with the Public Meetings Law, use a series of communications of any kind, directly or through intermediaries, for the purpose of deliberating, making recommendations, or deciding on any matter that is within the jurisdiction of the board. All board and committee members are encouraged to take the training offered by the Oregon Government Ethics Commission (OGEC) and to submit inquires to OGEC if unsure about compliance" and Amy Fellows provided a second to the motion. The board's first status report is due to Oregon Legislature on December 1, 2024 and is a requirement in Senate Bill 1089. Based on direction and feedback from the board over the last several months, staff created the final draft report and chair and vice-chair drafted an introductory letter for board members final approval.

 - Guide to solicit more public comment for the board and committees
- As other committees develop materials that need to be provided to the public, please engage the CECC.
- The committee has requested that the board member monthly talking points are also provided to CECC members.

Plan Design and Expenditures (PD&E) Committee, Chair Debbie Diaz:

- First meeting was focused on committee administration, overview of the workplan, committee process, values and principles, and a review of the Joint Task Force on Universal Care's recommendations

- Recommendation to the Finance and Revenue Committee to factor in auto insurance and how that will impact the final plan
