7. Maintenance

Maintenance Frequency/Maintain Records

- a. Inspect per manufacturer requirements. Preferably prior to the rainy season.
- b. Clean and maintain as necessary. Refer to Activity 125 in the Maintenance Guide for conditions when maintenance is needed.
- c. Keep a record of inspections, maintenance, and repairs.

Maintenance Guide/Maintenance Actions

Proprietary Water Quality Catch Basins have an operation and maintenance manual provided by the manufacturer. See Appendix C of the Standard Operational Manual for Water Quality Catch Basins. CG-3 MODIFIED INLET (SINGLE WATER QUALITY STRUCTURE)


