# **5/22/24 ADPC Prevention Subcommittee Recap Notes:**

### **ADPC & Other Updates**

- Director Annaliese Dolph updated the group that ADPC Senior Policy Analyst Tori Algee has accepted a new position with OHA to support Strategic Planning; ADPC is recruiting for four open positions.
- The \$13.7m Opioid Settlement Prevention, Treatment, and Recovery Board (OSPTRB) Prevention Funding Package was approved by the Board on 5/8, acknowledging strong support for primary prevention.
- Chair Debby Jones provided an overview of the 3 recommendations, acknowledging that this onetime funding is "booster funding," to showcase the work of prevention in Oregon, and build momentum for future investments.
- The ADPC Recovery Committee will present their recommendations in June to strengthen and expand recovery centers across the state.
- The ADPC Treatment Committee will present their recommendations in July to increase in Medication Units for Opioid treatment.

• Lisa Shields, OSPTR Board Manager, provided a high-level recap of OHA planning to support next steps for allocating funding (PowerPoint slides available on ADPC meeting webpage).

## Oregon Department of Education (ODE) Presentation of SB 238 Implementation

- Alexa Pearson and Suzanne Hidde, ODE, presented on SB 238 implementation (curriculum supplements on synthetic opioids and Good Samaritan law) and substance use prevention through health education (PowerPoint slides available on ADPC meeting webpage). Their presentation generated the following questions:
- Q: Is ODE aware that Oregon has a certified prevention workforce? Are there ways to strengthen the connections between local preventionists and schools? Is there a way to recognize preventionists as trusted partners?
  - Prevention partners can help ODE and local schools connect to local resources.
  - Including list of counties (including non-LPHA grantees) and CBOs in the Fentanyl Tool
     Kit to make it easier to connect with local preventionist.
  - We should really encourage schools to reach out to prevention partners for support.
- Q: How are supervisors/administrators invited into this practice?
  - Listservs, presentations at educator gatherings, like the Conference of Oregon School Administrators (COSA), and trainings/professional learning for health educators and administrators
  - Follow up: Could preventionists present at a COSA conference? We should consider submitting an ODE-OHA-local prevention partnership-panel abstract to COSA.
- Q: The Lund Report highlight gap for evidence-based programs is it on the list that ODE shares with schools?
  - ODE doesn't recommend a list of supplementary materials just criteria.
  - Schools have 36 weeks to cover many health-related topics, not just SUD; many supplemental health education resources are more in depth, multi-session interventions, and can't be implemented in schools.
- Q: What are plans for educating parents in conjunction with kids with the curricula?
  - ODE met with Songs for Charlie and they've offered to provide ongoing support/TA.
  - Curricula includes focus on how to also communicate with parents and caregivers even though primary focus in on students.
  - ODE is having supplements translated to make sure all materials are culturally and linguistically appropriate.
- Schools have core health education elements they have to cover within 36 weeks, which is not
  enough given all the complexities of student and family needs. We need a more comprehensive
  approach to better work together across all the systems (strategic planning,
  training/conferences). In essence, Oregon needs a system of care that works for kids and that in
  and of itself is prevention. How can we prioritize this so this can move into collective action?
  - ODE is willing to come back regularly to this group and is open to new ways of coordination. This is a stretch area for ODE, so new position will help with cross-sector coordination. New ODE position could also serve on the Prevention Professional Workforce Association.
  - ODE will forward the position description, which includes criteria that candidates have a background in prevention science.

## 2024-2025 Strategic Planning and Committee Membership Next Steps

- Tatiana reviewed work to date of the infrastructure work group
  - o Final edits to charter are ready for review and approval by full committee
  - o Membership matrix drafted that included sectors identified by the committee
  - Work plan draft not started
- Wes will reconvene work group to review work to date, finalize matrix, and develop process for committee members to complete matrix
- Recommend defining the categories before asking members to complete
