

Grant Request in Excess of \$150k

Per Oregon Administrative Rule (OAR) 738-124-0040

- maximum grant amount is \$150k
- Notwithstanding the \$150k, the Board may award a larger grant if it finds that a larger award for a particular project would serve the purposes of the program.
- Applicant should provide justification as to why awarding a larger grant amount would serve one or more of the purposes of the grant program

Other Considerations:

- Applicant must still meet the minimum match requirements in the OAR
- > 13 applicants requested a COAR grant amount of more than \$150k
- > ARC voted to recommend awarding full requests
