CALL TO ORDER:

McCracken Martin asked that the DOJ be added to the Executive Director hiring process to ensured all laws are followed.

OTHER: AAG McCracken said that she has been ill and that she, her supervisor, and Haag have a plan to involve a second AAG, Rachel Bertoni, to help Haag catch up on contested case backlog.
