Meeting Minutes August 4, 2023 Via Zoom Meeting

CALL TO ORDER:

The meeting was called to order at 9:00 a.m. by Chair Martin after a roll call quorum was established. The meeting was held via Zoom.

PREVIOUS MEETING MINUTES:

Williams moved to approve the minutes as distributed. The motion was seconded by Slough and passed unanimously.

AGENDA: Martin moved to approve the amended agenda as distributed. Costanza-Smith seconded and the motion carried unanimously.

ELECTION OF OFFICERS:

Martin nominated Clarence Williams to be Chairman of the Board. The vote was held and Williams was unanimously elected. Williams nominated Carrie Slough to serve as Vice Chair, and she was unanimously elected.

Williams said that he is delighted to serve as Chair, and said that Director Haag has done a good job on the budget, per the ways and means committee. He appreciates her checks and balances and board consistency. He prefers in-person meetings, is a people person, and he learns from the SLPs and audiologists and feels it is easier to dial in on consensus. Martin agreed that in-person meetings are preferable. Haag will check the budget but we can plan to have November in person.

RULEMAKING: Staff requested a rules change to clarify contested case rules as prepared by AAG McCracken. Martin moved that the rules be submitted for a permanent rules change. The motion was seconded by Williams and passed unanimously. Here is the language:

Chapter 335
Division 1
PROCEDURAL RULES
335-001-0007
Time for Requesting a Contested Case Hearing

- (1) In cases, other than those set forth in subsections (a) and (b) of this section, a A request for a contested case hearing must be in writing and must be received by the Board within twenty-one days from the date the contested case notice was served.;
 - (a) In cases of denial of licensure or refusal to renew a license (on grounds other than failure of an examination), a request for a contested case hearing must be in writing and must be received by the Board within sixty days from the date the contested case notice was served;
 - (b) In cases of emergency suspension, a request for a contested case hearing must be in writing and must be received by the Board within ninety days from the date the contested case notice was served.
