Committee Administration

Chair John Brown called the meeting to order at 1:30 pm.

Call for Public Comment - none received

Approval of minutes from January 2024 meeting – approved.

Property Acquisitions & Dispositions

1. Oregon Dept. of Fish & Wildlife / Minam Phase 3 – Acquisition Presented by Dick Duncan, ODFW

ODFW presented the third acquisition of the Minam project. Phase 3 adds two parcels in Union and Wallowa County totaling 1,100 acres to the 15,000 acres previously acquired in phases 1 and 2. The cost of the acquisition is \$1.4 million, \$950,000 from the US Department of Fish and Wildlife, and \$450,000 from the Rocky Mountain Elk Foundation. As Phase 2 was presented in July 2023 the presentation on Phase 3 was brief.

Discussion included:

- The value of the Minam project to habitat, conservation, threatened species, streams, connectivity between protected areas and recreation.
- Value of providing public access to areas often held for private use.

PLAC recommendation: Report accepted with a unanimous recommendation to OPRD to continue with the acquisition.

 Oregon Military Department / Hillsboro Readiness Center – Acquisition Presented by Gary Williamson, OMD

OMD presented details of the three-acre property that OMD is purchasing from the Port of Portland to increase the size of the 8-acre parcel OMD has owned since 2010. The original parcel was

purchased to provide a training and readiness center for the two units in the area. National Guard requirements have increased for the proposed facility since the original parcel was acquired leading to the acquisition of additional acres. The appraisal for the parcel and approval of the FAA due to being near an airport have been received. The transaction is expected to close next month.

Discussion included:

- Representative Tran noted from her experience with the Air National Guard that there is a need for significant space due to large numbers of participants on drill weekends.
- Value as supported by the two appraisals and review at \$1.96 million.
- Content of facility, including office space and drill hall with dual use rental option.

PLAC recommendation: Report accepted with a unanimous recommendation to OMD to continue with the acquisition.
