@Amber: CCIF. There were requests totaling 289 million dollars which if a lot more than what Business Oregon can award. 10 million was awarded in this 1<sup>st</sup> round. There was prioritization for culturally specific programs and providers. NWNC is contracted through DELC to provide TA, this is not only for awardees, but also for those going through the application process. NWNC can assist with grant writing and reporting also. There is a rough date of March to open applications for round 2. For those that were awarded W-9's are due by Monday, December 16<sup>th</sup>. NWNC has upcoming webinars for those who are interested. Subjects include planning projects, business planning and projections, project management, building marketing plans, capital planning best practices, etc.

# Tribal Early Learning Plan Follow-Up

# **Funding Proposal**

@Dana: Governor has released her recommended budget. This is exciting news. The budget recommendation includes new investment in the Tribal Early Learning Fund for 4.7 million, which would mean 4.5 million for tribes. 200k to remain with DELC to assist tribes, as decided by the OTELA body, for outside contracts.

The next step in for the legislature to vote to fund and pass the bill.

Other notable investments included in the GRB for DELC are for the birth through five literacy plan, infant early childhood, mental health consultation and Dolly Parton's Imagination Library.

- @Julie: Do you know the date that they are going to start working?
- @Kathy: The legislative sessions start on January 21<sup>st</sup> and typically the budget committees start meeting towards the end of January/Beginning of February. We have the Legislative concept approved, but we do not have a bill number yet. We can start tracking to see what committee it will be in and see how we can be part of that and play a role in moving the budget forward.
- @Sonya: Do we know when approximately we will find out if it is approved?
- @Kathy: They constitutionally must end by June 29th.
- @Dana: How soon would we hear about that, and the tribal hub funding will be being allocated as well. The current service level is 573k, which will basically be repurposed for the Tribal Early Learning Fund. Hopefully both happen. Could one happen before the other?
- @Kathy: The budget committees are typically the last to be worked on, before the June date. I believe that before the last day of session they will start moving and passing the budget. We should know a couple weeks before the June ending date if the budget has been approved and that it will move forward and then the date that the next biennium will start is July 1<sup>st</sup> 2025. Its really relevant to know when we will get the funding.
- @Sonya: is there any work that DELC will be doing to get the grants up? There is a consistent problem with getting the language. Th tribes deny when DOJ wants to waive tribal sovereignty. It takes so long to go through. Generally, we are not getting that funding until almost the 2nd biennium. Our tribe will not pre/postdates. We can not spend until those agreements are in place. This leads to tribes not being able to spend the money in the most meaningful ways. At times we have only one year, sometimes less than one year to spend after the agreements are signed.
- @Karla: It is tricky because the TELP and Fund haven't passed. We can work on it to some extent. Get boilerplate language and then complete when we find out if they have passed.
- @Dana: Assuming that we can do it, could we have an agreement for the biennium, that had the option of being extended for multiple years? Does that save the tribes time in the review process? Then it would be an amendment to the grant, or adding dollars, but the content would be the same.
- @Sonya: ODE grants around language and tribal history and shared history are continuations. It doesn't have to go through our clearing house, so it does cut the process time down.

- @Angela: It does because the legal team doesn't have to review the whole thing. They only review the amendment. The key is that the amendment must be adopted and accepted by Council before the expiration of the previous agreement. You can not amend something that has expired. The amendment would have to come to us well before the end of the agreement.
- @Dana: Any suggestions from tribes who manage multiple funding streams for other tribes who may want to do that? How to take tribal funding plus state funding and blend and braid.
- @Angela: We braid a lot of funds together to operate everything. It is complicated but doable. Multiple spreadsheets and management of grants and making sure that you are in compliance with all of them. If anyone is interested our ECE department program manager is a good resource to how she integrates all of that into our Early Education. We would love to share how we got to where we are. Maybe for future agenda items, we could do a rotation of sharing? A presentation of the different programs we offer and what funding we use to support each service.

@Dana: If you could be ready, we could add you in February.

@Angela: February will be doable.
