- OTELA Grant agreements went out last month. Checking in to see how the process is going and if there is any help needed.

- @Dana-Everyone please reach out with any questions/concerns as the process or language.

Language Tribal Early Learning Plan

Dana Castano, OTELA Liasian

- We will submit placeholder language next week. In the fall we will receive draft language back that we will share with the TAC and that will be an opportunity to review and make changes fi needed.
- Bill language review continues: OTELA Membership, Plan Strategies, DELC setaside.
- No quorum at this point in the meeting. We can still review and have a discussion, but will need to send out follow up emails
- We will capture the tribes that are present and their opinions

- OTELA membership reviewed with DOJ and looked at the Al/AN language. It is not necessary to have the number of members in statute, but it is recommended due to the need for quorum.
- Review slides (Draft Document)
- @Sonya-This will depend on what the committee looks like. Do we want quorum held to just tribes if we are including community partners? We need to establish who membership includes before we decide on quorum.
- @Dana- do you want community members to have a voting capacity on OTELA?
- @Sonya-What was the language under the original plan?
- @Alyssa-I have the original bill before it was amended, and the only non-voting members were the ELC rep and the DELC rep.
- @Sonya-all of the voices are helpful in giving perspective-I believe they should have a vote.
- @Jennifer-Concern. If OTELA is making decisions, do you want community members to have the same voice as a sovereign nation in making decisions.
- @Alyssa-Originally, they would have had the same voting rights as the tribes, so if the vision is they are advisory then they would be non-voting advisory reps.
- @Dana-Review ODE representation/OTELA differences
- QUORUM-Becky joins
- Review membership possibilities
- Only voting members are tribal representatives.
- Providers, Parents, DELC would be non-voting members.
- @Sonya-Do we need a member from the commission?
- @Alyssa-Not required, unless you all want to invite to meetings.
- Continue membership discussion
- @Crys-Concerning listing exact numbers for membership of community, there is leniency, you can put "up to__" number of parents, or providers
- @Jennifer and Sonya-What about tribes? What if we don't have 2 from each tribe
- @Crys-We can work that same language in to those members
- @Dana-also that nontribal members cannot back fill into tribal positions that may not be present
- @Alyssa-Yes, that those are not interchangeable
- @Angela-Yes and to make sure and clarify that the 5-9 quorum only includes those tribal reps appointed by the tribes. You may have a parent that is a tribal member, so we need to clarify. Must be tribally designated
- @Becky-it might be confusing language to say parents/providers required, but are non-voting

- @Alyssa-we can look at how to demonstrate the importance of the presence. They will have a seat for advisory purposes.
- QUORUM LOST
- @Dana-on to plan strategies. Clarifying intention
- "Native American languages and Tribal History/Shared History" was included based on April 9 TAC meeting.
- Members present 4-9 tribes agree. Email follow up to other members for consensus.
- @Jennifer-What happens if you lose quorum in the middle of the meeting. Can you continue business if we had previously met it?
- @Alyssa-quorum is required for formal action.
- @Crys-We can keep engaging in the discussion and deliberation. We just wouldn't be able to have any formal recommendations or decisions by the members.
- @Sonja-Should we put this item on the next agenda, or could we show the tribes that supported this and then send it out for others to weigh in?
- @Crys-this is not a formal adoption of language, it is still a discussion. What you
 could do now is note what each tribe has agreed to and then send it out via email
 and then see if there is agreement at the next meeting. The discussion doesn't need
 to end now.
- Continue language discussion
- 4-9 present Siletz, Grand Ronde, Coquille and Klamath support
- @Dana-Set aside discussion
- TAC talked about 5% set aside for DELC to provide PD and TA. Is that still accurate?
- @Sonya-is that 5% of base or does it include additional funds?
- @Alyssa-Just 5% of Tribal Early Learning Fund
- Jennifer-Where does funding for OTA positions come from?
- @Alyssa-Position funding does not come out of TELF. The 5% is specifically to assist the tribes with professional development and technical assistance.
- @Alyssa-You could also do a cap later. Something like "not to exceed 5%"
- 4-9 present Siletz, Grand Ronde, Coquille and Klamath support.
