

Plain language approach


Align with best practice, when possible

### What is a Rulemaking Advisory Committee (RAC)

A group of internal and external partners who come together to help implement rules in response to new or updated legislation.

RAC members provide input and suggestions for rulemaking while considering equity and fiscal impacts.

DELC/CCLD seeks diverse groups of individuals who interact with the agency and the programs run by the agency, such as child care providers, CCR&R and Early Learning Hub representatives, Tribal Nations representatives, union or advocate representatives, and parents and families of children.

# Family Child Care RAC Scope

#### The Family Child Care RAC Will Help Identify:

- Fiscal impacts (resources needed to implement the change)
- Equity impacts (unintended consequences that may impact specific groups or communities)
- Unclear rule language
- · Any unintended consequences as a result of the rule change
- Any additional resources that may be needed to support the implementation of these rules
