

Amendment xxx to Grant #xxx

This is Amendment X to Grant #XXX, dated X/X/XXX (executed agreement date), (as amended from time to time, the “Grant”), between the State of Oregon, acting by and through its Department of Early Learning and Care (“Agency”) and XXXX (“Grantee”). RECITALS

The purpose of this Amendment is to allocate additional slots and one-time new slot funds based on a reallocation of slots.

Funds provided in the Staff Supports category must be used on strategies that promote the recruitment, retention, and compensation of qualified staff. These funds must supplement and not supplant existing funding used for similar purposes/strategies.

Where awarded, one-time new slot funds may be used on allowable uses defined in the Grant Agreement.

- Section 6 of the Grant is amended as follows:

SECTION 6: GRANT FUNDS
