

# Supplemental Environmental Project Annual Progress Report: Friends of Trees June 2024

## Report produced by Owens-Brockway

### **Summary**

The Supplemental Environmental Project (SEP) tasked to Friends of Trees (FOT) under the Mutual Agreement and Final Order in Case No. AQ/V-NWR-2020-208, as amended, (MAO) has officially completed its second and final planting season. Since the SEP was approved in March 2022, Friends of Trees and various community partners have brought together over 1,800 community members to plant 6,961 trees and native plants across the Cully, Sumner, Parkrose, Argay and Wilkes neighborhoods, surpassing the original goal of 800 trees and 4,200 native plants. Of the 6,961 total plants, 4,666 were planted in the 22-23 season, and 2,295 were planted over the past year.

This report outlines the activities undertaken to achieve these milestones, as well as the outcomes, and final plans to complete the project approved in Exhibit A to the MAO. Reporting metrics, including volunteer numbers, demographics, planting metrics and financials can be found in the Appendix.

### **Volunteer Engagement & Project Outreach**

Throughout the second season of the SEP, community engagement remained an important goal for FOT. Overall, we engaged 803 volunteers for a total of 2,359 hours over the course of the past year.

During the 23-24 season, FOT attended multiple outreach events in the community and utilized various methods to recruit volunteers and tree recipients. This included hanging posters in prominent community locations, sending targeted mailings to the residents that live within the project area, and targeted outreach to past tree-recipients and volunteers.



In addition, FOT hosted one Crew Leader training session in the Argay neighborhood at Level Beer. The purpose of this event was to train community members to lead crews of volunteers at FOT plantings. At the event, trainees learned about the benefits of trees and healthy green spaces, the basics of planting and tree care, and facilitation skills. By hosting this event in the SEP geography, FOT not only brought in a new cohort of FOT leaders, but also spread awareness about this project and the impact of the work being done.

While FOT continued to work with various community partners through this project, many of them brought their own grant funds to support their time, and therefore did not bill FOT as originally planned.

## ***Planting & Event Overview***

Over the course of the 2023-2024 planting season, Friends of Trees hosted 8 public volunteer planting and stewardship events, 1 public training, and 2 educational plantings for school groups throughout the target project area. Our volunteers and community stakeholders planted 2,295 trees and native plants across 51 properties. General event details are outlined below; further planting details are outlined in Appendix B.

### ***Neighborhood Planting Events - Tree Planting***

FOT's neighborhood plantings are premised on engaging nearby community members to foster a sense of community through planting trees together. By planting trees in rights-of-way and on private properties, both residential and commercial, neighborhood planting events advance local urban forestry goals to increase urban canopy, inspire greater awareness of the benefits of trees, foster place-making, and strengthen community connections through shared experiences.

During the 23-24 season, FOT's Neighborhood Trees Program (NT) has hosted two different neighborhood tree planting events throughout the SEP project area. Each planting focused on two to three neighborhoods where volunteers planted between 50-100 trees. Attendees learned about the importance of urban trees as it relates to clean air and human health.

Additionally, NT hosted two education planting events. The first event was with students from Scott Elementary School, where FOT staff led 76 fourth grade students in planting 47 trees and shrubs on their school property. Students learned about the benefits of planting both trees and shrubs to support the ecosystem. The second planting event was with PSU's Environmental Justice class at Level Beer in the Argay neighborhood. Nine PSU students joined FOT staff to plant 28 trees and shrubs while engaging in discussions about the intersections between trees, heat islands, and human health through an environmental justice lens.

### ***Natural Area Planting Events - Small Stock Native Planting***



Friends of Trees' natural area programming is focused on working with community volunteers to restore urban greenspaces through planting native trees and shrubs and performing stewardship activities. Most of these projects are located next to streams and are driven by watershed health directives; however, others are undertaken to increase urban canopy in urban green spaces and create more shade and/or wildlife habitat, or along roadways to help filter out air pollutants and reduce stormwater runoff. In all cases, FOT's natural area work facilitates the restoration of appropriate plant communities to improve local ecosystems for the benefit of people and the environment.

Through this SEP project, FOT's Green Space Program (GS) hosted three public planting events, three public stewardship events, and one public Crew Leader Training event during the 23-24 season. These plantings happened across four project sites throughout outlined project area:

### **Gateway Green**

A 25 acre natural area nestled between I-205 and I-84, Gateway Green is just east of Rocky Butte at the previous location of the Rocky Butte Jail. There are a number of trails for off-road cycling, walking, and trail running, as well as built features for honing cycling skills.

### **Columbia Slough Natural Area**

Located just south of Airport Way in the Parkrose neighborhood, this natural area comprises ~1 acre along the confluence of multiple slough channels.

### **Wilkes Creek Headwaters**

Located in outer East Portland, Wilkes Creek Headwaters contains the springs that feed the only free flowing stream in the City of Portland that flows into the Columbia Slough, making this one of the most ecologically significant sites in the Columbia Slough Watershed. Planting at this site will reduce pollutants and erosion in the watershed, increase water quality and quantity by shading and filtering water, and improve hydrologic function by increasing water flow.

### **Level Beer**

Located at the interface of industry and natural space along NE 148th and Airport Way, this commercial property borders the slough. FOT has worked with property owners to design a functional landscape that will not only help to create critical habitat and filter harmful pollutants from entering the watershed, but also create a thriving, green community hub for residents of East Portland. In addition to hosting two planting events at Level, due to the habitat that has been added through this project, we hosted additional community events at Level to highlight the work, such as our end-of-season community Earth Month event in April

## ***Post-Planting - Monitoring & Care***

Now that planting is complete, FOT's primary focus for the duration of this project, and how much of the remaining staff hours will be spent, will be post-planting establishment and monitoring. FOT is committed to supporting our newly planted trees and shrubs to the best of our abilities, and working with residents and community members to help them steward their spaces. We do this through a combination of engaging the community, sharing resources, and staff hours spent maintaining our plantings.

All large stock trees that were planted through our NT program have been enrolled in our Summer Inspector Program, a community science initiative where volunteers are trained to assess the health of trees and share feedback and helpful tips with tree recipients. The trees that were planted this season will be visited twice throughout the summer by a trained volunteer and their assessments will be reported back to FOT for our records. Additionally, FOT staff will share tree care resources periodically throughout the summer to ensure tree recipients are fully aware about how to best care for their trees, including watering reminder emails, postcards, and informational door hangers. Level Beer, as an important community site for the neighborhood and dedicated site for this project, will also receive free weekly watering for all the trees planted at their site. Our small stock natural area plants will be actively cared for throughout the summer by FOT staff. Our team, alongside youth crews from Northwest Youth Corps, will visit all project sites multiple times throughout the summer to perform maintenance activities, including grass cutting, invasive management, mulching, and watering. In September, FOT staff will conduct survival monitoring to assess survivability at our natural area sites and help better inform management decisions we make in the future.

Survival data for all trees and plants will be shared in our final report in September of 2025.
