

## **Climate Protection Program:**

# **Covered Fuel Supplier List**

This document identifies covered fuel suppliers covered by the Climate Protection Program (CPP) beginning in 2025. Covered fuel suppliers are subject to the provisions of CPP. The first compliance period is 2025 - 2027 and the first demonstration of compliance is in 2028. This list is informed by data reported to DEQ's Greenhouse Gas Reporting Program and information regarding related entities, such as subsidiaries. This list is provided for informational purposes only. All persons are responsible for determining whether they are covered by the CPP and should consult the rules in Oregon Administrative Rules (OAR) chapter 340, division 273, to determine whether their interests may be affected by the CPP. Applicability provisions are in OAR 340-273-0110.

### **Covered Fuel Suppliers**

The below table shows covered fuel suppliers beginning in 2025. Liquid fuel(s) and propane suppliers are covered if their covered emissions are 100,000 metric tons of carbon dioxide equivalent (MT CO2e) or more in any year since 2020. Emissions are grouped for related entities, such as subsidiaries, when evaluating this threshold. This list is based on emissions from 2020 to 2023. The applicability threshold for liquid fuels and propane supplies declines over time from 100,000 MT CO2e to 25,000 MT CO2e. The following list does not include liquid and propane suppliers that would be covered entities as the threshold declines, for example at the 50,000 MT CO2e beginning in 2028.
