

# **Climate Protection Program:**

### **EITE and DNG Source List**

This document identifies emissions-intensive, trade-exposed sources (EITEs) and direct natural gas sources (DNGs) covered by the Climate Protection Program (CPP) beginning in 2025. Covered entities are subject to the provisions of CPP. EITEs and DNGs are exempt from compliance obligations during the first compliance period (2025-2027) and will not receive compliance instruments during this period. This list is informed by data reported to DEQ's Greenhouse Gas Reporting Program, based on reported data from 2020 to 2023. This list is provided for informational purposes only; All persons are responsible for determining whether they are covered by the CPP and should consult the rules in Oregon Administrative Rules (OAR) chapter 340, division 273, to determine whether their interests may be affected by the CPP. Applicability provisions are in OAR 340-273-0110.

#### **Covered EITEs and DNGs**

The below table shows covered EITEs and DNGs beginning in 2025. EITEs are covered sources if engaged in a sector described in OAR 340-273-9000 Table 7 and have covered emissions of 15,000 metric tons of carbon dioxide equivalent (MT CO2e) or more in any year since 2020. DNGs are covered sources if engaged in a sector not described in OAR 340-273-9000 Table 7, use natural gas distributed to the source by an entity other than a local distribution company, and have covered emissions of 15,000 metric tons of carbon dioxide equivalent (MT CO2e) or more in any year since 2020.
