


## ELECTRONIC HEALTH RECORDS UPDATE

Health Services at the Oregon Department of Corrections (DOC) would like to share more information about how the health information of adults in custody will be transferred to the new Electronic Health Records (EHR).

An EHR is like a big computer file that stores health information in one place. A “scanner” is a copy machine that turns a paper document into an electronic file that is safely and securely stored. Electronic records are easily shared between doctors, nurses, behavioral health, and dentists at DOC, and can be accessed at the same time.
