2. *Minutes

Approve the February 28, 2024, Meeting Minutes.

• Claire McGrew moved that the committee approve the minutes of the February 28, 2024, FPC meeting. Andy Ponce seconded the motion. The motion passes unanimously.

3. *Clayton R. Dieu: DPSST No. 39895

Presented by Brooke Bell-Uribe

DPSST received an E-1: Application for Certification Eligibility for Clayton Dieu on April 23, 2024. During their routine background and criminal history check on E-1 Applications for Certification Eligibility, DPSST staff found that Dieu had a criminal conviction in his history. On June 6, 2022, Dieu plead No Contest to and was convicted of California Vehicle Code (VC) 23153(b) Driving Under the Influence .08% Alcohol Causing Injury and Penal Code (PC) 12022.7(a) Enhancement Great Bodily Injury. This conviction of VC 23153(b) is designated as a felony conviction in the state of California in which a sentence of up to four years in prison may be imposed. The charge of PC 12022.7(a) carries an additional sentence of three years of in prison.

After review and discussion, the committee unanimously voted to Not Adopt the Staff Report and returned it to DPSST staff with instructions to find further information regarding the following: the status of Dieu's payment of fines and fees to the court, information about whether he completed any formal treatment for substance abuse as part of his probation, and whether he is utilizing his Commercial Driver's License (CDL). DPSST staff will research this information and present this case again at the November 20, 2024, Fire Policy Committee meeting.

* Proposed Rule Changes for Oregon Administrative Rule (OAR) 259-009-0087 Presented by Jennifer Howald

Accreditation of a fire service agency's training programs allows the fire service agency to teach DPSST approved training courses as in house training that can be used for fire service professional certifications. The accreditation agreement between DPSST and the fire service

agency serves to consolidate course certification, instructor certification, and fire service professional certification processes.

The standards and processes for accreditation are found in OAR 259-009-0087 and the DPSST R-1 Form. The rule sets the minimum standards for accreditation and the form facilitates the review process to determine if a fire service agency meets the minimum standards. DPSST administers the accreditation process in partnership with District Liaison Officers (DLOs). DLOs are volunteers who work with their local fire service agencies and act as a resource for navigating DPSST training and certification requirements. DLOs conduct accreditation reviews on behalf of DPSST. Completed reviews are submitted to DPSST. If no additional information is needed, DPSST will prepare a written accreditation agreement for the fire service agency.

It has been almost ten years since the accreditation standards and processes were reviewed in their entirety. On April 11-13, 2024, DPSST held a conference with DLOs from around the state to review the accreditation requirements and processes. The opportunity for review and discussion resulted in several updates to the accreditation review process and identified areas where the intent of the rules needed to be clarified. DPSST prepared proposed rule changes based on the feedback from the DLOs. The rule revisions also resulted in reorganization of the rule content.

- The FPC affirms the fiscal impact statement presented by staff.
- Andy Ponce moved to recommend that the Board approve filing the proposed rule changes for OAR 259-009-0087 as a permanent rule. Jack Carriger seconded the motion. Motion passes unanimously 7 to 0.

1. Agency Updates
