# lunteer Oppo

The Department of Public Safety Standards and Training is looking for volunteers who would be willing to participate in training sessions for Standardized Field Sobriety Testing in Salem, Oregon.

#### **Scenario Descriptions:**

#### Wet Lab Scenario

This is the first SFST testing the students will perform with the public. We ask volunteers to arrive by the shift start time. You will then be taken to Scenario Village to the Scenario Bar. It is set-up like a realistic bar, with a pool table, music, a piano and more. First off you will go through the pre-screening process, approximately a 10 min process that includes Medical Forms, Waiver Forms and Dosage Forms. You will then be served a specified dose of alcoholic beverages for testing purposes. During the time of being served beverages you will hang out, play cards, shoot pool, etc. Once the DPSST students arrive, you will step out on to the city streets, in scenario village, where the students perform the Standardized Field Sobriety Testing on you. You will then be released to your designated driver around the shift end time.

#### **DUII Scenario**

The second training the students will have involving volunteers from the public. We ask volunteers to arrive by the shift start time at DPSST Main Reception. You will be taken to the bar in scenario village and go through the pre-screening process and be served a specified dose of alcohol. Once you have reached the desired blood alcohol level you will be sent out in a vehicle with a driver who will demonstrate acts of impairment while driving the vehicle. A student will then pull over the vehicle. You will be asked to step out of the car and perform Standardized Field Sobriety Testing. You will be arrested and taken to our scenario jail. The student will then go through the process of booking you. You are then taken back to the bar and will then be sent back out to repeat the process.

#### **Requirements:**

- Must be at least 21 years of age (ID will be verified on day of training).
- Not currently/previously on probation for an alcohol-related offense.
- Not previously/currently an alcoholic.
- Not currently taking medication that will be adversely affected by consuming alcoholic beverages.
- Can not currently have hypertension (high blood pressure) or diabetes.
- Must arrange for transportation to & from the Academy (Taxi's/Ubers/Lyfts not allowed).
- No photo taking devices are allowed—including cell phones with cameras.
- No intimate touching such as hugging, kissing, groping, holding hands, etc.
- Must be able to control emotions and self while under the influence of intoxicants. If problems occur you may be asked to leave.
- Must wear long pants and closed toe shoes (tasteful attire please).
- Can NOT be/have been a full-time or reserve law enforcement officer.
- Can NOT be employed with DPSST in any capacity including Role players.
- Can NOT show up with alcohol in system.
