The Department of State Lands manages approximately 750,000 acres of Common School Fund trust lands on behalf of the State Land Board. The State Land Board, by and through the Department of State Lands (DSL), is responsible for the management and disposition of these state-owned lands.

This notice is to inform you that the following Common School Fund Land parcel in Deschutes County will be considered for potential sale:

**Stevens Road Tract, Bend, OR: 643.71 acres south and east of the intersection of Stevens Road and 27<sup>th</sup> Street in Township 18 South, Range 12 East, Section 11, Tax Lots 1700 and 1800.**

This trust lands parcel was approved by the State Land Board on October 17, 2017 for DSL to move forward with conducting the appropriate due diligence needed for these lands to be considered for sale at a future date. Numerous due diligence studies will be performed including archaeological, endangered plants and animals, and appraisals.

The Department will collect public comments on the potential land sale until November 16<sup>th</sup>, 2019. Once the public comment period has ended and all due diligence reports have been received, the Department will make a recommendation to the State Land Board on whether or not to sell the parcel. The State Land Board comprised of the Governor, Secretary of State, and the State Treasurer, will then decide to sell the parcel or not.

The Department will hold a **public meeting on October 29<sup>th</sup>, 2019 from 5:30 to 7:30 pm** at Fellowship Hall, Nativity Lutheran Church, 60850 Brosterhous Road, Bend, OR 97702. This meeting will be informational only and will not allow for public testimony. Public comment must be received in writing through this notice, at the below listed website, or at the public meeting.
