The Oregon Department of Energy (ODOE) is developing the Oregon Energy Strategy that will identify pathways to achieve its energy objectives. The strategy will evaluate tradeoffs of different pathways and include policy recommendations. Developing the Oregon Energy Strategy will follow a three-phase process that combines data gathering, technical analysis, scenario modeling, and input from Oregonians with diverse backgrounds and perspectives, as well as from communities all over the state.

There are many opportunities to share input and contribute throughout the development of the Oregon Energy Strategy. All Advisory Group and Working Group meetings will be open to the public to attend. Additionally, ODOE will host several open opportunities for Oregonians to learn the latest about the Energy Strategy and provide feedback.
