Executive Summary

As required by law, this implementation status report is produced by the Wildfire Programs Director every two months for the Governor, the Presiding Officers of the Oregon Legislature, and the chairs of relevant legislative committees.

Wildfire Program Highlights

The Wildfire Programs are guided by the 19-member citizen council: Wildfire Programs

Advisory Council (WPAC). The WPAC is appointed by the Presiding Officers, and October 11, 2024 marks the first rotation to half of the membership on this Council. The Wildfire Programs Director is grateful to all the members who have served on the WPAC, volunteering their time to ensure Oregon continues to confront the mounting challenges that come with more complex wildfire conditions across the state.

Please note updates to the "Wildfire Programs Implementation Status" section of the report includes two new reports required by the 2024 legislature: HB 2016 report on home hardening and SB 5701 Budget Note # 5 report on options for sustainably funding wildfire.

The remaining portion of the executive summary will be dedicated to summarizing the 2024 fire season which has resulted in one of the most challenging fire seasons in Oregon's history.

To-date, wildfires across Oregon have burned over 1.9 million acres. The state's 10-year average acres burned, for the full fire season, is 640,000 acres. Details on today's wildfires can be tracked at: Wildfires Dashboard (arcgis.com), including a weather warning, which currently (September 30, 2024) calls for increased fire potential in southwest Oregon due to high winds. The morning briefings report on the Northwest Coordination Center's website has been as complex as we have seen in Oregon's history. Oregon's fire season typically ends by mid-October with the fall pattern of rains setting in.



To-date, Oregon has lost 42 primary residences and 132 additional structures. Seventeen conflagrations have been initiated by the Governor to support the fighting of fires immediately threatening our population centers. Forty-six separate wildfires have threatened structures, initiating evacuation notices for over 30,000 residences. FEMA has approved twelve Oregon fires as eligible for Fire Management Assistance Grants and the state is filing for a Major Disaster Declaration to assist with recovery. A state declaration of emergency was issued for wildfire, providing access to the National Guard firefighting resources and making available stateto-state agreements for additional fire protection resources. The State's Emergency Coordination Center was stood up to include daily calls with all county and Tribal emergency managers, all state wildfire response and supporting agencies and other partners.

Our thoughts remain with the families of fire fighters and support staff who lost their lives in Oregon's wildfire effort this year.

In summary, Oregon is once again experiencing a historic wildfire season with tremendous losses accumulating. Gross suppression costs from ODF and OSFM have exceeded \$300 million.

The WPAC's annual report is due to the Legislature and the Governor in October, and will no doubt shed light on the important steps forward we must consider to prepare for these increasingly complex wildfire issues.

Duties of the Wildfire Programs Director

- Oversee implementation of the Wildfire Programs.
- Coordinate activities across all wildfire implementation agencies.
- Ensure compliance with deadlines.
- Monitor and assess the equity of any financial impacts from implementation activities on local jurisdictions.
- Supervise council staff and develop director reports every two months.
- Explore current and future opportunities to reduce wildfire risk.



Roles of the Wildfire Programs Advisory Council

- Advise and assist the Wildfire Programs Director.
- Monitor Wildfire Programs implementation and evaluate agency reports.
- Advise on changes necessary to dramatically reduce wildfire risk and ensure regional defensible space, building codes and land use applications are appropriate.
- Strengthen intergovernmental and multiparty collaboration including government, stakeholders and the public.
- Assess how Oregon's wildfire risk map may inform building codes and land use laws, rules and decisions in a regionally appropriate manner.
- Assess the application of defensible space requirements to vineyards, crops and other cultivated vegetation.
- Review the findings and recommendations in the DLCD's October 2022 report and make additional recommendations to land use planning, local comprehensive plans, and zoning codes to minimize wildfire risk.
- Report every October to the Governor and appropriate committees or interim committees of the Oregon Legislative Assembly.
