In response to guidance from OCTAE <u>published in Federal Register</u> on December 12, 2024: Updated CASAS Reading GOALS "Approved Until" date: Sunset date of June 30, 2025

Corrected CASAS Appraisal for Reading GOALS test administration time from 15 minutes to 30 minutes

Oregon PY24-25 Assessment Policy Change List (list of changes in April 2024; changes are updated from list below, which was submitted with PY24-25 Assessment Policy in October 2023)

General: In response to Notice in Federal Register that sunset period has been extended until June 30, 2025, removed all references to BEST Plus 3.0 and approved use of BEST Plus 2.0 through June 30, 2025.

Removed references to CASAS accommodations available as of September 2023 (pp. 24 and 33). Revised sections "CASAS Accommodations in Test Administration Procedures" and "Appendix A: Guidelines for Providing Accommodations Using CASAS Assessment for Learners with Disabilities" to reflect updated guidance from <u>CASAS Testing Accommodations and Accessibility</u>.

General: Replacing references to BEST Plus 2.0 to BEST Plus 3.0 throughout document.
