<b>Accessibility</b> Measurable characteristics that indicate the degree to which a system is available to, and usable by, individuals with disabilities. The most common disabilities include those associated with vision, hearing, mobility, and cognitive disabilities.	دسترسی پذیری

<b>Amendment</b> A change to the U.S. Constitution or the constitution of a state. Voters must approve changes to a constitution.	اصلاحیه

<b>At Large</b> The whole membership or population rather than a subset.	در کل
<b>Attorney General</b> An elected, state-level, partisan officer who is responsible for providing legal representation to the Oregon state government and running justice programs related to child support, district attorney assistance, crime victims, and consumer protections.	دادستان کل
<b>Audio Format</b> A format where information is communicated through sounds and speech.	قالب صوتی
<b>Audit</b> (1) A systematic, independent documented process for determining the extent to which specified requirements are fulfilled. (2) A review of a system and its controls to determine its operational status and the accuracy of its outputs.	حسابرسی
<b>Automatic Voter Registration</b> An automatic, nonaffiliated voter registration process through qualifying interactions at the Driver and Motor Vehicle Services (DMV).	ثبت نام خودکار رأی‌دهندگان
<b>Ballot</b> A paper form with contests (a list of candidates for office) and ballot measures (proposed laws or amendments) that voters mark to make choices. What contests are on each voter's ballot depends on where that voter lives (which jurisdictions and districts the voter lives in).	برگه رأی
<b>Ballot Box</b> An official, sealed container that holds ballots cast by voters.	صندوق رأی
<b>Ballot Drop Box</b> An official, locked container, either indoor or outdoor, where voters can return a ballot for collection by an election official.	صندوق اخذ رأی

<b>Ballot Envelope</b> Official envelopes used to transport or enclose ballots.	پاکت رأی

<b>Ballot Measure</b> A question that appears on the ballot for a proposed law, act, or part of an act of the Legislative Assembly, or a revision of or amendment to the Oregon Constitution.	همه پرسی

<b>Ballot Secrecy</b> A set of rules and procedures to ensure the fundamental right of voters in the United States to cast a secret ballot. <b>Ballot Title</b> The official short summary of a ballot measure that appears on a ballot, which consists of a caption, the question to voters, and a summary of the measure and its major effects.	عنوان رأی گیری

<b>Bill of Rights</b> A set of legal and constitutional protections ensuring the opportunity to vote in free and fair elections. In Oregon, these are called the Oregon Voter Bill of Rights.	منشور حقوق
<b>Blind</b> Having very limited or lack of vision.	نابینا
<b>Board of Canvassers</b> An official group following specific rules and procedures to compile, review, and validate election materials.	هیئت شمارش و بررسی آرا

<p><b>Bond</b> A debt obligation issued by jurisdictions to fund major capital improvement projects over time. Bonds are generally repaid through property taxes. <p><b>Cast</b> The final action a voter takes in selecting contest options and irrevocably confirming their intent to vote as selected.</p>	انداختن رای

<b>Certified Ballot</b> A ballot that has been certified by the county clerk through the ballot counting process.	رای تأیید شده
<b>Certified Election Results</b> Final vote tallies that have been attested as true and accurate by the official responsible for confirming their accuracy.	نتایج تأیید شده انتخابات
<b>Certify</b> The act of a third party giving written assurance that a product, process, or service conforms to specified requirements.	تأیید کردن
<b>Challenged Ballot</b> A ballot that is held for further research because there is a question about whether it should be counted.	رای مورد تردید

<b>Change of Address</b> The act of a voter re-registering to vote to update their residence or mailing address.	تغییر آدرس
<b>Charter</b> A legal document that creates and sets rules for a municipal or local districts. Oregon is a home rule state which means that incorporated municipalities can make limited rules that have the force of law. Document by a legislative authority, such as a city or county, that defines the laws and regulations of that body.	منشور
<b>Check the Box</b> The act of marking a vote on a ballot.	انتخاب گزینه
<b>Checks and balances</b> A system that allows each branch of government to amend, override, or veto acts of another branch to prevent any one branch from exerting too much power or power beyond its authority.	موازنه قوا

<b>Circuit Court</b> Oregon general jurisdiction trial courts in judicial districts that decide all types of civil and criminal cases.	دادگاه حوزه قضایی
<b>Circuit Court Judge</b> Oregon nonpartisan elected officials in judicial districts, adjudicating on legal matters in the state system of trial courts.	قاضی دادگاه حوزه قضایی
<b>Circulate</b> The act of attempting to gather signatures from voters for initiatives, referendums, or candidates.	توزیع برگه‌های امضا
<b>Citizen</b> A person who, by place of birth, nationality of one or both parents, or naturalization is granted full rights and responsibilities as a member of a nation or political community.	شهروند

<b>City</b> An incorporated local government body within a state.	شهر

<b>City Council</b> The governing body of a city consisting of members elected by voters.	شورای شهر
<b>City Councilor</b> City Council members elected to represent city residents, often by geographic voting districts.	عضو شورای شهر
<b>City Hall</b> A building used as offices by people working for a city government.	شهرداری

<b>Clerk</b> An official responsible for administering an election or an election process.	مسئول انتخابات
<b>Close of Registration</b> The last day that a citizen can register to vote or update their voter registration before an election.	پایان ثبت‌نام
<b>Closed Primary</b> Major political parties in Oregon hold closed primary elections to choose candidates to represent them in general elections. Oregon law allows major political parties to decide whether to hold open or closed primary elections. In a closed party election, only voters who are registered with the major political party can vote for the candidates in that party's primary. Voters receive a ballot listing only those candidates running for office in the major political party with which the voters are affiliated, along with nonpartisan races and ballot measures. Voters not registered with a major political party receive a ballot listing only nonpartisan candidate races and ballot measures in a closed party primary election.	انتخابات اولیه بسته

<b>Count</b> (1) Process of totaling votes. (2) The number representing the result of totaling numbers of votes.	شمارش
<b>County</b> One of 36 political and administrative divisions of Oregon, providing certain local government services and governed by boards of commissioners or county court.	کانتی

<b>Deadline</b> The last day or time to complete actions for a specific election or election processes.	مهلت مقرر
<b>Deaf</b> To have a hearing loss so severe that there is very little or no functional hearing.	ناشنوا
<b>Declaration of Candidacy</b> The act of completing the required paperwork to become a candidate for public office.	اعلام کاندیداتوری
<b>Defective Ballot</b> A ballot that has been torn, defaced, or marked in a way that it cannot be tabulated by a scanner.	رای مخدوش
<b>Delegate</b> An authorized person chosen to represent each state at a political party's convention.	نماینده
<b>Democracy</b> A government in which the supreme power is vested in the people and exercised by them directly or indirectly through a system of representation usually involving periodically held free elections.	دموکراسی
<b>Democratic (political party)</b> A major political party in Oregon.	دموکرات (حزب سیاسی)
<b>Department of Administrative Services (DAS)</b> Central administrative agency of Oregon state government which works to implement the policy and financial decisions made by the Governor and the Legislature and ensure accountability of state government. <b>Department of Revenue (DOR)</b> State agency which administers Oregon tax laws, processes revenue, and acts as the central debt collection agency for other state agencies, boards, commissions, and local governments.	اداره درآمد (DOR)
