New Contract Rules in Effect January 2, 2024

Beginning January 2, 2024 all landscape contracting businesses <u>must</u> include a "Notice of Right to Cancel a Contract" page in written contracts.

Landscape jobs totaling \$2,000 or more must be performed with a **written** contract.

Protect yourself by making sure your contracts meet the 13 essential elements of a Landscape Construction Contract:

- 1. Landscape contracting business name, license number, business physical address, mailing address, and telephone number;
- 2. Homeowner/Consumer's name and address:
- 3. Address or location of work to be performed if different from the homeowner/consumer's address;
- 4. General description of the work to be performed and the materials to be installed;
- 5. Estimated time for completion or estimated completion date;
- 6. Price and payment schedule;
- 7. Description of guarantee; if no guarantee is being provided, a statement that no guarantee is being provided;

Important Changes to Contract Requirements (continued)

- 8. Signatures of the authorized business representative and homeowner/consumer;
- 9. Statement that the business is licensed by the State Landscape Contractors Board and the current address and phone number of the board.
- 10. If subcontractors will be used for the performance of any landscaping work, the contract must include a statement notifying the homeowner/consumer subcontractors may be used.
- 11. If the contract contains an arbitration clause, the contract must include language explain that if the homeowner/consumer signs the contract, the homeowner/consumer may be waiving their right to access the Board's claim process and may not have access to the landscape contracting business' bond.
- 12. Starting January 2, 2024, A "Notice of Right to Cancel Contract" page must be attached to the written contract. This Notice explains the consumer has three business days to cancel a contract and that the cancellation must be in writing, and clearly state the contract is being canceled. This form also has a place where the consumer may waive that three-business day period.
- 13. A form of electronic communication such as fax, email, or text messaging the consumer can use to send a cancellation notice to the landscape contracting business within that three-business day period.

Contracts missing one or more of the required elements are subject to a civil penalty and may not be enforceable by the landscape contracting business.

Do You Have the Correct Surety Bond?

Bonds are one of the most important consumer protection tools available. It important to make sure your bond is current and appropriate for the size of jobs your business contracts and bids. Landscape contracting businesses are responsible for keeping their bond up to date.

Remember:

- If you have a job, or are bidding on a job, that grows to more than your bond allows, you must increase your bond immediately.
- If your bond pays out on a claim, you must pay back the bond company and make sure they do not cancel your bond or reduce your bond amount.

The Board has been seeing an increase in the number of businesses performing landscape jobs greater than the bond allows. In some cases the jobs have higher contracts from the start, and in some cases the jobs have change orders that put the landscape job over the bond limit.

Check the chart below to make sure your bond covers the amount of work your company performs:

| BOND AMOUNT | JOB CHARGE |
|-------------|---|
| \$3,000 | \$0 up to and including \$10,000 or less |
| \$10,000 | More than \$10,000 but less than \$25,000. |
| | Also, if you are installing walkways, driveways, patios, decks, fences, arbors, retaining walls NOT in conjunction with a landscape job |
| \$15,000 | \$25,000 but less than \$50,000 |
| | or Probationary All Phases licenses |
| \$20,000 | \$50,000 or greater |
| | |

Protect Yourself! You can receive a \$1,200 civil penalty for having an insufficient bond and suspension of the license until the bond is increased.

Avoid license renewal delays by keeping your business registry up-to-date with Secretary of State!
