**RE:** Land Conservation and Development Commission Hearing on the Appeal of the Director's Partial Approval of McMinnville's Sequential UGB Amendment Work Program Task 1 Submittal (Order 001943)

Dear Mayor Drabkin,

The Department of Land Conservation and Development (DLCD) received two appeals of DLCD's Partial Approval of Sequential UGB Amendment Work Program Task 1 Submittal (Order 001943) during the 21-day appeal period. One was transmitted on August 21, 2024 from 1000 Friends and Friends of Yamhill County and the other on August 22, 2024, from Mark Davis. The Land Conservation and Development Commission (LCDC) will hear the matter on October 25<sup>th</sup>, 2024 (a virtual only meeting). DLCD will transmit the staff report and recommendation concerning the appeal of DLCD Order 001943 by October 4<sup>th</sup>, 2024, if not earlier.<sup>1</sup>

Commission rules allow the city and persons who filed valid objections and appeals to file written exceptions to the staff report that DLCD will transmit. The exceptions must be filed with DLCD within 10 calendar days from the date the subject staff report is sent (see OAR 660-025-0160(5)). LCDC will make a final decision on the submittals based on the written record and oral arguments based on the written record. LCDC will consider oral argument at the hearing, limited to the city and those who filed valid objections or an appeal (see OAR 660-025-0085 and OAR 660-025-0160). In order to complete the hearing in the available period, LCDC may limit the time for argument.
