Updates to policies of the Oregon Coastal Management Program (OCMP) within the Oregon Department of Land Conservation & Development

NOTICE

Pursuant to 15 CFR Section 923.84 (federal Coastal Zone Management Act regulations), the federal Office for Coastal Management (OCM) has concurred that the incorporation of the following statutes and administrative rules constitute "program changes" to the Oregon Department of Land Conservation and Development's (DLCD) federally-approved Oregon Coastal Management Program (OCMP).

PROGRAM CHANGES

OCM concurred with the incorporation of the following statutes and administrative rules into the Program, with certain clarifications, qualifications, and exceptions as described in the OCM decision letter dated 8/3/23. These policies are effective for federal consistency reviews as of June 10, 2024:

- Oregon Revised Statute 274 Submerged and Submersible Lands

- Oregon Administrative Rule 141-083 Rules for Granting Easements for Fiber Optic and Other Cables on State-Owned Submerged and Submersible Land Within the Territorial Sea
- Oregon Administrative Rule 250 (partial) Oregon State Marine Board
- Oregon Administrative Rule 142 South Slough National Estuarine Research Reserve
