#### Summary description of project

The City of Burns proposes to utilize TGM grant funds to comprehensively address the anticipated transportation challenges arising from significant housing expansion within two new master planned communities. This project aims to achieve the following key objectives: (1) Modernize the outdated Burns Transportation System Plan, ensuring it aligns with current and future transportation needs, growth projections, state/federal regulations, and crucially, the specific transportation requirements of the Burns Paiute Tribe's trust lands within the city limits; (2) Develop a robust, multimodal transportation plan that caters to the needs of all users, including pedestrians, cyclists, public transit users, and motorists, promoting safe and efficient mobility options; and (3) Conduct a thorough analysis of the transportation impacts associated with the new subdivisions, identifying needed infrastructure improvements, traffic flow optimizations, safety enhancements, and equity considerations.

What is the transportation or transportation-related land use issue, problem, need, or opportunity the proposed project will address?

The proposed project addresses several key transportation and land use issues in Burns:

Outdated Transportation Plan: The current Transportation System Plan (TSP) is outdated (nearly 25 years old) and does not reflect the current or future needs of the growing community. This hinders effective planning and decision-making for transportation investments.

Rapid Growth and Development: The city is experiencing significant growth, with two new subdivisions adding hundreds of new homes over the next five years. This will strain the existing transportation infrastructure, creating potential congestion and safety issues if not adequately addressed.

Limited Connectivity for Tribal Lands: The Burns Paiute Tribe's trust lands within the city limits lack a comprehensive street network, hindering their development and economic potential. This lack of connectivity also limits access for tribal members and isolates the Tribe from the broader community.

Insufficient Accessibility: The existing transportation system lacks adequate accessibility for pedestrians, cyclists, and individuals with disabilities. This limits transportation options and creates inequitable access to essential services and opportunities.

The proposed project will address these issues by:

Updating the Transportation System Plan to reflect current and future needs, including those of the Burns Paiute Tribe.

Developing a comprehensive transportation network that prioritizes connectivity, safety, and accessibility for all users, including pedestrians, cyclists, transit riders, and motorists.

Integrating land use and transportation planning to ensure that future development is strategically located and designed to minimize traffic congestion and promote sustainable transportation options.

By addressing these interconnected issues, the project will create a more efficient, equitable, and sustainable transportation system that supports the needs of all residents and fosters a thriving community.

### What are the proposed Project Objectives? How will the Project Objectives achieve one or more of the TGM Objectives?

The City of Burns proposes to utilize TGM grant funds to comprehensively address the unique transportation challenges and opportunities presented by significant housing expansion and the integration of tribal trust lands into the city's transportation network. This project aims to achieve the following key objectives:

- (1) Transportation System Plan (TSP) Update and Integration: Modernize the outdated Burns Transportation System Plan, ensuring it aligns with current and future transportation needs, growth projections, state/federal regulations, and, crucially, the specific transportation requirements of the Burns Paiute Tribe's trust lands within the city limits.
- (2) Connectivity and Accessibility for Tribal Lands: Develop a comprehensive transportation plan that prioritizes the connection of the Burns Paiute Tribe's currently disconnected properties (old camp and new camp) within the city's Urban Growth Boundary (UGB). This will involve designing a complete street network that facilitates safe and efficient access for tribal members and enables the Tribe to fully utilize and develop its land holdings adjacent to the Miller Springs subdivision and Burns I/E Zone.
- (3) Multimodal Transportation Planning for All: Develop a robust, multimodal transportation plan that caters to the diverse needs of all users, including pedestrians, cyclists, public transit users, motorists, and individuals with disabilities. This will involve expanding ADA-accessibility options, such as new trails, sidewalks, and street improvements, in line with the standards set by recent developments.
- (4) Economic Development and Community Integration: Leverage transportation infrastructure investments to support the Burns Paiute Tribe as a pillar of the community and the I/E Zone and new housing as economic engines for the region. By ensuring that the Tribe and Harney County can fully participate in and benefit from the city's growth and development, this project will foster greater community integration and economic opportunity for all.
- (5) Subdivision Impact Mitigation and Climate Resilience: Conduct thorough analysis of the transportation impacts associated with the two new subdivisions and I/E Zone, identifying necessary infrastructure improvements, traffic flow optimizations, and safety enhancements to mitigate potential congestion and ensure seamless integration with the existing transportation network. Incorporate strategies to reduce greenhouse gas emissions from the transportation sector and enhance the resilience of the transportation system to the impacts of natural hazards.

By undertaking this holistic and inclusive planning effort, the City of Burns aims to proactively address the transportation needs of all residents, including the Burns Paiute Tribe, while promoting economic development, community cohesion, and a safe, accessible, and sustainable transportation system that supports a high quality of life for all.

#### Why is it important to do the proposed project in this grant cycle?

The urgency to complete this project in the current grant cycle is driven by several converging factors:

Rapid Growth and Development: The City of Burns is experiencing significant housing and econmic growth, with two new subdivisions approved to add hundreds of new homes, and the improvements to the county's I/E Zone being funded for construction in 2024. This influx of residents and potential new businesses will place an immediate strain on the existing transportation infrastructure, making it imperative to proactively plan for and implement improvements to accommodate this growth.

Tribal Land Development Opportunity: The Burns Paiute Tribe's desire to access and potentially develop its trust lands presents a time-sensitive opportunity to integrate their properties into the city's transportation network. This will not only facilitate economic development for the Tribe but also enhance connectivity and accessibility for the entire community.

Outdated Transportation Plan: The current Burns Transportation System Plan (adopted in 2001) is nearly 25 years old and no longer reflects the current or future needs of the community. This outdated plan hinders effective decision-making and resource allocation, making it crucial to update it promptly to ensure that transportation investments align with current growth and development patterns.

Funding Availability: The TGM grant provides a unique funding opportunity to address these pressing issues, and the City has a five-year commitment with Business Oregon to build 160 homes, of which 48 (30%) must be affordable to 130% area median income households (or below). Delaying the project would risk missing out on this critical funding source, potentially hindering the city's ability to implement necessary transportation improvements in a timely manner with its housing projects.

Community Momentum: There is currently a strong community interest and momentum for improving transportation infrastructure in Burns. This project has the potential to capitalize on this momentum from new housing construction and foster collaboration among stakeholders to create a shared vision for a safe, efficient, and equitable transportation system.

By prioritizing this project in the current grant cycle, the City of Burns can proactively address these challenges and opportunities, ensuring that the community's transportation system can support its growth and development while enhancing the quality of life for all residents.

This is the third consecutive year the City of Burns has applied for a TGM grant. In our earlier applications, the Miller Springs and Palmer Estates subdivisions (and the I/E Zone) were concepts. Then plans. They are now construction-ready projects. Miller Springs final engineering and design and the I/E Zone final design are complete, the infrastructure is fully funded, and both projects are scheduled to go out for bid this summer with an award in the fall and construction to begin by October. These developments went through multiple rounds of public hearings and funding applications over the last two years to get to move from concept to construction. The City is ready to move forward with its TSP updates and has done the necessary work to implement these projects over the next five years.

This project aligns with ongoing efforts in Burns, including the development of Miller Springs (out for bid) and Palmer Estates (final planning) subdivisions, the I/E Zone (out for bid) and recent ADA-accessibility improvements (in progress). It will support the Burns Paiute Tribe's land development (future work) by addressing their need for a comprehensive street network. The project's outcomes will inform future decisions on workforce housing location and overall community growth, ensuring a well-connected and accessible transportation system for all.

Specific outcomes desired are: Complete Streets Design, Robust Community Engagement, Multimodal Transportation (especially in underserved areas), Improved Land Use Integration, and Data Driven Decisionmaking.

We anticipate adoption of these through planning commission hearings and public hearings with the City Council upon completion of the TSP update, likely within 24 months of award.

Burns has hried Catalyst Public Policy Advisors LLC, a specialized consulting firm that is well-equipped to provide the additional resources and expertise necessary to support the project's successful completion. This includes access to a team of experienced planners, engineers, and other relevant professionals who can contribute their knowledge and skills to ensure that the project is executed efficiently and effectively. Catalyst has raised over \$6 million in funding for City projects in the last two years and has the capacity to assist the City in overseeing its grant reporting and planning obligations. Along with City staff, Catalyst will assist the TGM consultant in conducting a thorough analysis of existing conditions, engagement with stakeholders, identification of needs and priorities, and development of a comprehensive plan that addresses the diverse transportation challenges and opportunities in Burns. How will the adoption of the final document(s) address barriers to a broad range of housing types and affordability or work to link the location of future workforce housing to walkable/bikeable areas with good transit?

The grant will directly support diverse housing development for workers, young families, retirees, and aging seniors. The City has a contractual obligation to build 160 homes over the next five years, of which 48 homes (30%) must be for residents at or below 130% area median income. Palmer Estates has 110 lots planned for single and multifamily housing catering to low and middle income residents. The updated TSP will directly address barriers for this broad range of housing types and affordability in Burns, while promoting walkable, bikeable, and transit-accessibile transportation choices.

#### CITY OF BURNS, OREGON RESOLUTION NO. 790

## A RESOLUTION OF THE CITY OF BURNS, HARNEY COUNTY, OREGON, APPROVING A TRANSPORTATION GROWTH MANAGEMENT GRANT APPLICATION

WHEREAS, City of Burns ("City"), an Oregon municipal corporation, has all powers that the constitutions, statutes, and common law of the United States and Oregon expressly or impliedly grant or allow City; and

WHEREAS, City's City Council ("Council") intends to create certain street and utility improvements to enhance City's livability, walkability, to promote economic development, and otherwise increase community vitality; and

WHEREAS, City anticipates certain housing developments and surrounding publiclyowned lands to require additional streets, multimodal paths, recreational amenities, and other infrastructure improvements to be constructed within a multimodal corridor to increase the efficient delivery of public services, including promoting the health, welfare, and general safety of City's residents; and

WHEREAS, these improvements may require comprehensive plan amendments and transportation facility improvements within City's urban growth boundary that require an integrated planning and transportation approach (collectively, the "Project"); and

WHEREAS, the Oregon Department of Land Conservation and Development and Oregon Department of Transportation may award Transportation Growth Management Planning Grants to help local jurisdictions plan for streets and land to lead to more livable, sustainable, and economically vital communities (the "TGM Grant");

I am writing on behalf of the Miller Springs Development to support the City of Burns 2024 Transportation Growth Management grant application.

I am a 5th Generation rancher and landowner in Harney County, with the 7th generation of my family now deeply embedded in the community. My family first came to the region before Oregon achieved statehood in the late 1850s and has been here ever since.

My family owns 1,200 acres of land on the western city limits of Burns, where we are currently developing the Miller Springs master-planned community. Phase 1 is adjacent to the County's I/E Zone, which abuts our multifamily zoned property and about 30 acres of our land zoned for Business Park in Phase 1 of the Miller Springs development.

We are coordinating closely with the Burns Paiute Tribe, City of Burns, and Harney County and see a significant opportunity for collaboration between these parties as we plan for this area's development.

We aim to provide a 20-year land supply of buildable residential, commercial, and industrial properties and recreational lands for the Burns/Hines area. We'll achieve this through a public-private partnership (P3) investment approach that leverages local, state, and federal investment from the public sector with cash, equity, and opportunity zone investment from the private sector.

Phase 1 (160 homes) is now fully approved and ready for construction. We have raised over \$6 million in capital for the infrastructure improvements scheduled to begin construction this fall.

We encourage you to award this technical assistance grant to help the City of Burns plan update its Transportation System Plan (TSP), improve connectivity to the Burns Paiute Tribal Trust Lands, improve multimodal transit choices, and increase opportunities for housing growth and economic expansion.
