Call to Action—Opportunity to Serve on the Oregon Board of Naturopathic Medicine

The Oregon Board of Naturopathic Medicine (<u>Board-ORS</u>) is currently <u>recruit-ing two Naturopathic Physicians</u> licensed in the State of Oregon to serve a three-year term as a member of the Board.

<u>Applications will be accepted from September 5—20 (Due to updates in the Governor's Ex. Appointment system—link to the membership application will be sent in a separate email after Sept 1.)</u>

There are seven members on the Board; five licensed Naturopathic Physicians and two public members. The Board meets bi-monthly, the second Monday of all even months.

Member responsibilities include (Board OAR), but are not limited to:

- Review administrative investigations to determine if a licensee committed a violation of an Oregon Administrative Rule (OAR) or Oregon Revised Statute (ORS).
- Advise Board staff on best practices, and communicate with the public and licensees on issues related to the practice of Naturopathic Medicine.
- Engage in administrative rule making and propose legislative concepts to carry out the mission of the Board.

Oregon Health Authority Administrative Rule—COVID-19 Vaccine Mandate

Governor Brown directed <u>Oregon Health Authority</u> to issue temporary rule <u>OAR</u> <u>333-019-1010</u>—COVID-19 Vaccination Requirement for Healthcare Providers and Healthcare Staff in Healthcare Settings. This rule mandates <u>ALL health care</u> <u>workers, in ALL health care settings to be fully vaccinated</u>. This rule is <u>adminis-</u> <u>tered and enforced by the Oregon Health Authority</u>.

The Board of Naturopathic Medicine is not able to provide any legal advice regarding compliance with, or aid in interpreting a rule written, and/or implemented by another agency. <u>Please direct ALL inquiries regarding this rule, including enforcement and exemptions, to the Oregon Health Authority.</u>

Key Provisions of the Rule:

- Section (1) (d) (A) & (B) defines / applies to ALL health care settings
- Section (1) (e) (A)-(C) defines / applies to ALL naturopathic physicians and ALL licensed and/or unlicensed staff.
- Section (1) (f) and (1) (g) define vaccine exemptions:
 - (f) "Medical exception" means that an individual has a physical or mental impairment that prevents the individual from receiving a COVID-19 vaccination.
 - (g) "Religious exception" means that an individual has a sincerely held religious belief that prevents the individual from receiving a COVID-19 vaccination.
- Section 2 (b) Documentation of a <u>medical or religious exemption</u>:
 - (A) A medical exception must be corroborated by a document signed by a medical provider, who is not the individual seeking the exception, on a form prescribed by the Oregon Health Authority, certifying that the individual has a physical or mental impairment that limits the individual's ability to receive a COVID-19 vaccination based on a specified medical diagnosis, and that specifies whether the impairment is temporary in nature or permanent.
 - (B) A religious exception must be corroborated by a document, on a form prescribed by the Oregon Health Authority, signed by the individual stating that the individual is requesting an exception from the COVID-19 vaccination requirement on the basis of a sincerely held religious belief and including a statement describing the way in which the vaccination requirement conflicts with the religious observance, practice, or belief of the individual.
- Weekly Covid testing is no longer an alternative option in lieu of vaccination. All (non-exempt) naturopathic physicians and staff are required to be vaccinated by October 18 or six weeks after full FDA approval, whichever is later.

Board of Naturopathic Medicine—Oregon Revised Statutes, Administrative Rules

ORS Chapter 685 contains laws (statutes) passed by the legislature to govern the occupation and profession of Naturopathic Medicine in the State of Oregon. The Board makes and enforces laws called administrative rules. Administrative rules are developed and enacted through a rule-making process, which includes public input. <u>OAR Chapter 850</u> regulate the profession of Naturopathic Medicine. Licensees must follow the Board's regulations set forth in the Oregon Revised Statutes (ORS) and Oregon Administrative Rules (OAR). A licensee may be disciplined for violation of both statutes and administrative rules.

The Board has made numerous changes to Administrative Rules in the last 12 months. **Please ensure that you read in full all of the newly adopted Board Administrative rules to ensure compliance:**

Administrative Rules Adopted October 2020 – August 2021 – Effective Immediately

<u>850-001-0010</u> – **Requiring an Answer to Charges as Part of Notices to Parties in Contested Cases:** Sets forth conditions and requirements for a hearing request and answer by the licensee or the licensee's attorney in contested cases.

<u>850-010-0301</u> — **Mask, Face Covering, Face Shield Requirements** For the duration of the state of emergency, all licensed Naturopathic Physicians in the State of Oregon must wear and require all individuals to wear masks, face coverings or face shields upon entry and at all times while in an indoor health care setting. <u>*This rule was implemented as a Permanent Rule in March 2021.</u>

850-010-0100 – Mode of Remittance (Repealed-text moved to 850-030-0035)

<u>850-010-0310</u> – **Duty to Create, Maintain and Retain Medical and Billing Records**: Establish criteria and standards for creating, maintaining, retaining patient medical records and enables the Board to impose discipline for failure to follow standards and requirements.

850-010-0350 - Public Requests for Board Records

850-030-0035 - Fees for Licensure, Examination, and Certification

850-060-0212 – **Education Requirements for Injection** / **IV and Chelation Therapy :** Sets forth education, training, and reporting requirements for injection / IV and Chelation Therapy. <u>* This</u> rule was revised and amended further—changes implemented in August 2021 to clarify reporting and education requirements.

0-060-0212—Education and Reporting Requirements for Injection and IV Therapy.

This rule requires specific education and training prior to, and to continue to engaging in Injection and IV Therapy

Licensees must provide the proof of education and training required on / before December 31, 2021 to practice IV and injection therapy after January 1, 2022.

Application of the Rule: This rule applies to ALL licensees that engage in injection and IV therapy. Completion of education and training is required per section of the rule, prior to engaging in the therapy described in the corresponding section of the rule. Completion of each section of the rule is required prior to moving on to the therapy described in the next section of the rule.

Reporting Requirements: Licensees may report / sub application for approval for submit an education and training completed prior to the adoption of this rule.

The rule allows licensees that have practiced IV and Injection therapy for more than 10 years to submit to the Board a CV and a letter of explanation of equivalent training and education per rule. [Section 6 (b)]

Licensees engaging injection and / or IV therapy for up to 10 calendar years must submit to the Board a record of training and education per rule. [Section 6(c)]

The Board will post continuing education reporting guideline and a reporting form on the Board Nebsite on October 1, 2021.

Legislative Update-2021-2023 Session

HB 3369 Relating to Medical Marijuana:

Adds Naturopathic to the list of attending providers that may diagnose a patient with a debilitating medical condition and have the authority to issue a registry identification card for the purposes of dispensing medical mariiuana.

SB 5521 — Budget Approval Board of Naturopathic Medicine.

The Legislature approved the Board of Naturopathic Medicine's operating budget, retaining its status as an autonomous agency reporting directly to the Governor.
