### SECTION 2. PROGRAM AND POSITION INFORMATION

a. Describe the program in which this position exists. Include program purpose, who's affected, size, and scope. Include relationship to agency mission.

The mission of ODA is, Protect, Promote, Prosper, Safeguarding Oregon's diverse communities, natural and working lands, and economies by responding to the changing needs through assistance, compliance, and promotion of food and agriculture as one ODA. In addition to supporting the department's mission, these programs help fulfill several objectives in the department's strategic plan, including a culture of compliance and support and excellence in customer service.

Water quality compliance encompasses water quality protection for both the non-point and point source agricultural operations. Point source compliance is achieved through the permitting and inspection of Confined Animal Feeding Operations (CAFOs). The program regulates livestock operations to prevent and control water pollution and watershed degradation from livestock operations. Oregon's permit program includes both state and federal water quality regulations. The number of permitted livestock operations is

DAS Form - 2006 (Rev 2024) Page 1 of 7 about 500. Operating according to the conditions of the permit assures that animal wastes are not discharged to waters of the state.

Non-point source compliance is achieved through work with farmers and ranchers in Oregon to prevent and control water pollution from agricultural activities and soil erosion. The water quality program works closely with Soil and Water Conservation Districts and other partners to conduct its work. The program's responsibilities include adopting rules establishing required conditions on agricultural lands to protect water quality, evaluating agricultural lands for compliance with required conditions, conducting onsite inspections to evaluate agricultural lands for compliance, and when necessary, using a progressive approach to achieve compliance. The program is outcome-based and strives to provide farmers and ranchers with flexible options to comply with required outcomes and achieve the state's water quality goals.

Achieving and maintaining a high level of compliance that protects ground water and surface water from exceeding water quality standards, thereby protecting the beneficial uses of water including drinking, irrigation, recreation, wildlife habitat, etc. The beneficial uses of water are important to the public. It is critical to the sustainability of Oregon agriculture that livestock operators comply with state and federal water quality laws to assure that water resources continue to be available.

The fertilizer program is directly involved in obtaining compliance with state laws regulating fertilizers including agricultural minerals, limes, and agricultural amendments. The Oregon Department of Agriculture (ODA) Fertilizer Program inspects and registers fertilizer, agricultural mineral, lime, and agricultural amendment products (referred to as "products" in this document) distributed in Oregon. These products must be registered with ODA before they can be distributed in Oregon. The purpose for regulating and monitoring products is to create accurate labeling, guaranteed product analysis, and environmental protection.

The Water Quality Compliance Program Manager primary purpose is to serve as the program leader and manager for the CAFO & Fertilizer programs to ensure a high degree of professionalism and service to meet the mission of the individual programs under direct supervision and to ensure that the mission, core values and strategic plan for the agency are achieved. This position has particular emphasis on overseeing the program's compliance inspections and enforcement work for the protection or water quality and the states natural resources.

This position is responsible for decisions that direct the day-to-day operations and performance of the programs. Determines compliance of laws and rules permits, and enforcement actions. Interprets laws and rules and works with the Natural Resource Program Administrator to set policy interpretations. Recommends program operational and procedural changes to program administrator. Prioritizes workload, assigns, and directs work of staff.

This position applies the agricultural water quality program's philosophy of providing flexible means to achieve required environmental outcomes and applying a progressive compliance approach to achieve those outcomes. Decisions made in this position affect budget priorities, program priorities, enforcement actions, policies and procedures, and personnel considerations. Results of activities conducted are often

controversial and can have economic impacts to agricultural landowners. The position frequently needs to balance and consider the interrelatedness of environmental outcomes with economic impacts. Position regularly contacts and is contacted by farmers and ranchers, Soil and Water Conservation District staff, state natural resource agency staff, university research and extension personnel, Oregon Department of Justice, conservation organizations, grower organizations, and the public. The performance of position duties follows federal and state laws, administrative rules, department policies, scientific principles and accepted investigative techniques.
