Reminders

Distribution of unregistered products in Oregon is a violation of ORS 633.366(1)(e). Registration fees are nonrefundable per ORS 633.366(3). A registrant *must* receive written verification from the Oregon Department of Agriculture (Department) that a product is registered *before* a product is sold, offered for sale, or distributed in or into Oregon. A registration certificate will be mailed upon completion of the registration process. Product registration may also be checked anytime at: https://oda.direct/MyLicense

Incomplete forms, missing heavy metals laboratory reports, missing or incomplete product labels, or insufficient registration fees can lead to significant delays in product registration. The heavy metals laboratory reports must also include the detection limits and methods used and list the total concentration of arsenic (As), cadmium (Cd), lead (Pb), mercury (Hg), and nickel (Ni) in the product. Also, the detection limits must be at or below the following: arsenic (As) 10.0 ppm, cadmium (Cd) 5.0 ppm, lead (Pb) 5.0 ppm, mercury (Hg) 0.20 ppm, and nickel (Ni) 5.0 ppm. The heavy metals laboratory report must have been conducted within the prior 18 months to submission of the application to the Department.

If your application is revewied and fails to meet the requirements of ORS 633.311 to 633.479, the application will be refused. If your application is refused, you will need to re-apply for registration by re-submitting a completed application form, appropriate fee(s), label(s) and heavy metal laboratory report(s).
