

NEED FOR THE RULE(S)

The United States Department of Agriculture (USDA) has confirmed at least 492 cases of H5N1 Highly Pathogenic Avian Influenza virus in dairy cattle in at least 15 states since March 2024. ODA originally enacted emergency temporary rules to issue import restrictions to dairy cattle from affected states in April 2024. Since that time, the USDA has issued a federal order requiring pre-movement testing for all lactating dairy cattle moving interstate. This rule will adopt the federal order, while also permanently adopting the state-specific requirements included in the now-expired emergency temporary rule.

STATEMENT IDENTIFYING HOW ADOPTION OF RULE(S) WILL AFFECT RACIAL EQUITY IN THIS STATE

These rules are not anticipated to impact racial equity in this state.

FISCAL AND ECONOMIC IMPACT:

Failure to adopt rules could result in the introduction of HPAI into the State of Oregon, potentially leading to significant costs to control the disease and economic losses to impacted dairy farms and the dairy industry as a whole.

DESCRIBE HOW SMALL BUSINESSES WERE INVOLVED IN THE DEVELOPMENT OF THESE RULE(S):

This rule was initially developed in April 2024 with input from the Oregon Dairy Farmer's Association providing input on behalf of Oregon dairy farmers.

WAS AN ADMINISTRATIVE RULE ADVISORY COMMITTEE CONSULTED? NO IF NOT, WHY NOT?

This rule is adopting a federal order issued by the USDA, as well as adopting temporary rules that have been in place since April 2024.

ADOPT: 603-011-1222

RULE SUMMARY: Adoption of federal order related to HPAI control in dairy cattle, as well as permanent adoption of specific import requirements for dairy cattle originating in a state where HPAI has been diagnosed in dairy herds within 30 days prior to importation.

CHANGES TO RULE:

603-011-1222

Import Requirements - Highly Pathogenic Avian Influenza

In addition to the requirements of OAR 603-011-1100 and any other import requirements, the following shall apply to the importation of livestock susceptible to influenza:¶

(1) As used in this rule this rule:¶

(a) "Exposed cattle" means any cattle that have been on the same premises as infected cattle or a suspected case

within the previous 30 days.¶

(b) "Federal Order" means the Federal Order Requiring Testing for and Reporting of Highly Pathogenic Avian Influenza (HPAI) in Livestock, issued by the USDA APHIS on April 24, 2024.¶

(c) "Infected cattle" means any cattle testing positive for HPAI.¶

(d) "Suspected case" means any cattle exhibiting clinical signs of HPAI.¶

(2) All dairy cattle imported into Oregon must comply with the requirements for interstate movement specified in the Federal Order, in addition to the specific requirements below:¶

(a) No exposed cattle, infected cattle, or suspected case may be imported into Oregon.¶

(b) Dairy cattle that are not exposed cattle, infected cattle, or a suspected case, but that originate from a state with a suspected case or infected cattle within the previous 30 days, must be accompanied by:¶

(A) A Certificate of Veterinary Inspection that was completed no more than 7 days prior to importation into Oregon; and ¶

(B) A valid import permit issued by the Department pursuant to OAR 603-011-1100(5).
