NEED FOR THE RULE(S)

Livestock ID program is fully supported by inspection fees. For the program to maintain the program at its current service levels a fee increase is required. In addition, the industry seeks to have the program operate more efficiently, so options for fees associated with inspection related delays and added resource needs are included to recover costs incurred outside the programs ability to control.

STATEMENT IDENTIFYING HOW ADOPTION OF RULE(S) WILL AFFECT RACIAL EQUITY IN THIS STATE

Amendments to these rules will not impact racial equity.

FISCAL AND ECONOMIC IMPACT:

The Livestock Identification Program is 100% fee based. The effect of the rule changes is that an additional estimated \$ 200,000 will be collected annually from cattle per head inspection fee.

Increase in fees will impact the cattle industry, including ranches, auction yards, dairy farms, and feed lots.

(2) Effect on small businesses: (a) estimate the number and type of small businesses subject to the rule(s); (b) Describe the expected reporting, recordkeeping and administrative activities and cost required to comply with the rule(s); (c) Estimate the cost of professional services, equipment supplies, labor and increased administration required to comply with the rule(s).

Fees will impact entire cattle industry, estimated at 15,000 farming operations throughout the state, including cattle ranch operations, dairy farms, feed lots, auction yards, and processing facilities. The rule changes are not expected to change the reporting or administrative costs as the fee collection system is existing infrastructure.

Livestock Brand advisory committee involved with rule drafting process and provided substantial input into rule language creation and approval.

AMEND: 603-014-0055

RULE SUMMARY: Adds language for a discretionary waiting fee if livestock are not presented in a timely manner.

Adds provisions for billing of department costs associated with a 'no show' for scheduled inspections.

Adds language for hourly billing and mile traveled rates for services provided that do not fall under the per head model.

CHANGES TO RULE:

603-014-0055

Service Fee ¶¶

(1) The service fee provided for in ORS 604.046(2) shall apply any time a livestock program employee travels specifically with the intent to conduct a brand inspection.¶¶

(2) The service fee is \$35 per travel location.¶¶

(3) At the discretion of the livestock program, a waiting fee may apply any time a livestock inspector travels specifically or the responsible person are unavailable at the scheduled inspection time or if there is an interruption of the inspection where a livestock program employee is unable to perform their inspection duties. The time spent waiting by the livestock program employee shall be considered waiting time. ¶¶

(a) The program employee must notify a representative of the person requesting the inspection of the initiation of

**GRANT CONTRACT AMENDMENT #1
BETWEEN THE
OREGON DEPARTMENT OF AGRICULTURE
AND
UMATILLA COUNTY (Grant # ODA-4514-GR)**

This Amendment modifies the grant contract between the Oregon Department of Agriculture (ODA) and Umatilla County (Grantee), signed by ODA on April 17, 2024, for the Wolf Compensation and Financial Assistance Grant Program. The revisions to the grant are limited to those specified below. All other provisions of the grant remain in effect.

Umatilla County is hereby awarded an additional \$15,000 in Category 3 funds as specified in Section 2 of the original grant award. These funds are designated for the implementation of prevention and/or nonlethal wolf deterrence techniques. The allocated funds were initially returned to ODA by Umatilla County from the 2023 grant period due to non-utilization. Given that the purpose of these funds aligns with ongoing preventative measures, the ODA is regranteeing these funds to Umatilla County for their intended use.

RULE SUMMARY: Modified Service Fee billing to allow for a fee for each inspector.

Clarified that a Service Fees exemption exists for a brand inspector that is in training by the department.

CHANGES TO RULE:

603-014-0065

Service Fee Exemptions ¶

~~(1) The service fee required described by in OAR 603-014-0055 shall not apply to the following:¶~~

~~(1) Cattle and equine when livestock~~ that are presented for inspection at place where a livestock inspector program employee is present, and the owner or occupant of that place allows the use of their property to conduct the inspection. The service charge may or may not have already been paid by the person who caused the inspector to be at that place.¶

~~(2) At auction markets where multiple inspectors are required,~~ livestock program employees are necessary to adequately inspect cattle livestock prior to their sale, only sale, one service fee will be charged per sale for each assigned livestock program employee per sale event.¶

~~(3) A service fee may not be charged for a livestock program employee that is in training by the Department.~~

RULE SUMMARY: Increases inspection per head to \$ 1.35.

Modifies Transportation book fees to match updated cost and includes cost of shipping/handling.

CHANGES TO RULE:

603-014-0095

Brand Inspection Fee ¶

(1) The brand inspection fee for cattle, ~~as provided by ORS 604.066(2)~~, shall be \$1.135 per head.¶

(2) The brand inspection fee for cattle hides shall be \$1.50 per hide.¶

(3) The brand inspection fee for self-inspection (E--certificates) on cattle shall be \$1.135 per head.¶

(4) The charge for cattle transportation certificates, ~~as authorized by ORS 561.180(4)~~, printed by the Department shall be \$43.50 per book plus postal or freight charges for shipping the requested certificate books sent first class or bulk rate based on weight.
