NEED FOR THE RULE(S)

The Weights and Measures Program is 100% funded by annual device license fees. These fees are paid by all businesses employing commercial weighing and measuring equipment commercially in the State of Oregon. It is hard to imagine many products or commodities that are not weighed or measured many times from production to consumption/disposal and it is the program's primary mission is to ensure that the equipment used is fair, unbiased, and otherwise worthy of the trust we place in them every day. The program maintains a staff of 21 field staff deployed statewide along with the vehicles and associated equipment needed to inspect and test some 64,000 licensed devices on an annual basis. The license fees set in this rule provide the funding necessary to carry out these inspection and device testing duties.

STATEMENT IDENTIFYING HOW ADOPTION OF RULE(S) WILL AFFECT RACIAL EQUITY IN THIS STATE

No impact is anticipated.

FISCAL AND ECONOMIC IMPACT:

Little to no fiscal impact to state agencies, units of local government, or the average citizen. An approximate \$450,000 fiscal impact spread over 2 years dispersed across approximately 12,000 small businesses in Oregon that license and operate approximately some 64,000 weighing and measuring devices with ODA.

State Agencies:

Oregon Department of Agriculture is the agency responsible for enforcing these rules. The license fees collected pursuant to ORS 618.136 are used entirely to fund the Weights and Measures device testing and inspection program.
Oregon Department of Transportation. The Weights and Measures Program tests and certifies ODOT highway weigh station scales annually.

Local Government:

• County governments operating weigh stations certified by the Weights and Measures Program (including Lane, Jackson, and Marion counties).

Local Government:

• County governments operating weigh stations certified by the Weights and Measures Program (including Lane, Jackson, and Marion counties).

In all the Weights and Measures program tests 89 scales at highway weigh stations operated by ODOT and county governments. The impact of this amendment will largely be felt in the testing fees charged by ODA to these entities and will be very minimal given the small number of devices involved.

Members of the Public:

• Customers of the approximately 12,000 businesses operating in Oregon use some 64,000 ODA licensed commercial weighing and measuring devices daily including those found at all retail gas stations and grocery stores. The public may see minimal increases in related goods and services as these license fee increases may be passed along to their customers as a part of the normal cost of doing business.

a) Estimate the number of small business and types of businesses and industries with small businesses subject to the rule:

Approximately 12,000 businesses operating in Oregon are potentially affected by these amendments.

b) Projected reporting, recordkeeping and other administrative activities required for compliance, including costs of professional services:

This is a license fee increase only. There will be no new reporting, recordkeeping, or other administrative requirements.

c) Equipment, supplies, labor and increased administration required for compliance:

This is a license fee increase only. There will be no new equipment, supplies, or other additional administrative activities required to comply with the rules.

DESCRIBE HOW SMALL BUSINESSES WERE INVOLVED IN THE DEVELOPMENT OF THESE RULE(S):

The Oregon Fuels Association (OFA), the Renewable Energy Group (REG), the Western States Petroleum Association (WSPA), the Oregon Trucking Association (OTA), Northwest Grocer's Association (NWGA), AAA of Oregon, Kinder Morgan, the Northwest Propane and Gas Association are all members of the Weights and Measures Advisory Committee and were consulted. These members were all contacted via email and notified of the proposed rule change and given opportunities to offer input and advice.
