## Overview of Plan

#### House Bill 2656

Relating to improvements in student success.

#### **SECTION 3**

- (1) The Superintendent of Public Instruction shall convene an advisory committee to explore options for expanding or revising the education accountability framework in this state.
- (2) The advisory committee convened under this section must include representatives or school districts, teachers' unions and post-secondary institutions of education.
- (3) The advisory committee convened under this section (3) must review accountability programs in other states and make recommendations to the superintendent on the expansion or revision of the education accountability framework.

#### Role of the Advisory Committee

Make recommendations to the Superintendent of Public Instruction (Governor Tina Kotek, and by delegation, Dr. Charlene Williams) on the expansion or revision of an education accountability framework.

- Over the next eight months, you will focus on, contemplate, and grapple with central questions aimed at providing recommendations for:
  - What do we care about? What do we value? What do we want our public education system to look like and feel like, for our children, our families, our educators, our communities?

#### How will we accomplish this?

- Examine our core values and beliefs
- Learn about and offer recommendations on:
  - what we currently have in place (state & federal) inspection report
  - what do other states value
  - what do other countries value
  - what do educators value
  - what do our youth value
  - what do our families value

January 2025

June 2024 First draft of possible recommendations

• August 2024 Second draft of recommendations

September 2024 Finalize recommendations

• October 2024 Report (framework) due to Dr. Williams and Governor Kotek

Pay attention (neighbors, yourself, group process and dynamics)


